MAXIMUM ALLOWANCE PAYABLE. 10 (a) In General.—Paragraph (2) of section 5948(a) 11 of title 5, United States Code, is amended by striking "\$20,000" and inserting "\$30,000". 12 13 (b) AUTHORITY TO MODIFY EXISTING AGREE-14 MENTS.— 15 (1)IN GENERAL.—Any service agreement 16 under section 5948 of title 5, United States Code, 17 which is in effect on September 30, 1997, may, with 18 respect to any period of service remaining in such 19 agreement, be modified based on the amendment 20 made by subsection (a). 21 (2) Limitation.—A modification taking effect 22 under this subsection in any year shall not cause an 23 allowance to be increased to a rate which, if applied 24 throughout such year, would cause the limitation 25 under section 5948(a)(2) of such title (as amended
