## A BILL

To amend title XVIII of the Social Security Act to provide for payment for hospital outpatient department services equal to payment rates established for similar services provided outside the hospital setting.

- 4 This Act may be cited as the "Medicare Hospital
- 5 Outpatient Payment Fairness Act of 1997".
