A BILL

To amend title 5, United States Code, to expand the class of individuals under the Civil Service Retirement System eligible to elect the option under which the deposit which is normally required in connection with a refund pre-

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Civil Service Retirement System Actuarial Redeposit Act of ~~1997~~ 1998”.

6 **SEC. 2. EXPANSION OF CLASS OF ELIGIBLE INDIVIDUALS.**

7 (a) AMENDMENT TO ELIMINATE LIMITATIONS RELATING TO DATE OF SEPARATION AND PERIOD OF SERVICE TO WHICH REFUND RELATES.—Clause (i) of section 8334(d)(2)(A) of title 5, United States Code, is amended to read as follows:

12 “(i) has received a refund described in paragraph (1);”.

14 (b) AMENDMENT RELATING TO THE COMMENCEMENT DATE OF AN ANNUITY.—Clause (ii) of section 8334(d)(2)(A) of title 5, United States Code, is amended by striking “December 2, 1990” and inserting “the date of the enactment of the Civil Service Retirement System Actuarial Redeposit Act of ~~1997~~ 1998”.

20 (c) APPLICABILITY.—For purposes of any annuity commencing before the date of the enactment of this Act, this Act shall be treated as if it had never been enacted.
