#### 1 SECTION 1. 2-YEAR EXTENSION OF VISA WAIVER PILOT

- PROGRAM.
- 3 Section 217(f) of the Immigration and Naturalization
- 4 Act is amended by striking "1997." and inserting
- 5 "1999.".

#### 6 SEC. 2. DATA ON NONIMMIGRANT OVERSTAY RATES.

- 7 (a) COLLECTION OF DATA.—Not later than the date
- 8 that is 180 days after the date of the enactment of this
- 9 Act, the Attorney General shall implement a program to
- 10 collect data, for each fiscal year, regarding the total num-
- 11 ber of aliens within each of the classes of nonimmigrant
- 12 aliens described in section 101(a)(15) of the Immigration
- 13 and Nationality Act (8 U.S.C. 1101(a)(15)) whose author-
- 14 ized period of stay in the United States terminated during
- 15 the previous fiscal year, but who remained in the United
- 16 States notwithstanding such termination.
- 17 (b) Annual Report.—Not later than June 30,
- 18 1999, and not later than June 30 of each year thereafter,
- 19 the Attorney General shall submit an annual report to the
- 20 Congress providing numerical estimates, for each country
- 21 for the preceding fiscal year, of the number of aliens from
- 22 the country who are described in subsection (a).
