A BILL

To protect the privacy of individuals with respect to the Social Security number.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Social Security Privacy
- 5 Act of 1997".

- THE SOCIAL SECURITY NUMBER WITHOUT
- 3 CONSENT.
- 4 (a) IN GENERAL.—Part A of title XI of the Social
- 5 Security Act (42 U.S.C. 1301 et seq.) is amended by add-
- 6 ing at the end the following:
- 7 "PROHIBITION OF CERTAIN MISUSES OF THE SOCIAL
- 8 SECURITY ACCOUNT NUMBER
- 9 "Sec. 1146. (a) Prohibition of Commercial Ac-
- 10 QUISITION OR DISTRIBUTION.—No person may buy, sell,
- 11 offer for sale, take or give in exchange, pledge or give in
- 12 pledge, or request as a condition of entering into a con-
- 13 tract, any information for the purpose of conveying by
- 14 means of such information any individual's social security
- 15 account number without the written consent of such indi-
- 16 vidual.
- 17 "(b) Prohibition of Use of Social Security
- 18 Number.—No person may utilize any individual's social
- 19 security account number without the written consent of
- 20 such individual.
- 21 "(c) Prerequisites for Consent.—In order for
- 22 consent to exist under subsection (a) or (b), the person
- 23 engaged in, or seeking to engage in, an activity described
- 24 in such subsection shall—

- 1 "(1) inform the individual of all the purposes
- 2 for which the number will be utilized and the per-
- 3 sons to whom the number will be known; and
- 4 "(2) obtain affirmatively expressed consent in
- 5 writing.
- 6 "(d) Limitation.—Subsections (a) and (b) shall not
- 7 apply with respect to the last 5 digits of an individual's
- 8 social security account number.
- 9 "(e) Exceptions.—Nothing in this section shall be
- 10 construed to prohibit any use of social security account
- 11 numbers permitted or required under section 205(c)(2) of
- 12 this Act, section 7(a)(2) of the Privacy Act of 1974 (5
- 13 U.S.C. 552a note; 88 Stat. 1909), or section 6109(d) of
- 14 the Internal Revenue Code of 1986.
- 15 "(f) Regulation by States.—Nothing in this sec-
- 16 tion shall be construed to prohibit any State authority
- 17 from enacting or enforcing laws consistent with this sec-
- 18 tion for the protection of privacy.".
- 19 (b) Effective Date.—The amendment made by
- 20 this section applies with respect to violations occurring on
- 21 and after January 1, 1999.
