## A BILL

For the relief of Rosalba Colunga de Medina, Claudia Janet  
Alexandru Medina, and Jose Armando Medina, Jr.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. PERMANENT RESIDENT STATUS FOR ROSALBA**

4                       **COLUNGA DE MEDINA, CLAUDIA JANET**

5                       **ALEXANDRU MEDINA, AND JOSE ARMANDO**

6                       **MEDINA, JR.**

7       (a) IN GENERAL.—Notwithstanding subsections (a)  
8       and (b) of section 201 of the Immigration and Nationality  
9       Act, Rosalba Colunga de Medina, Claudia Janet  
10       Alexandru Medina, and Jose Armando Medina, Jr., shall

1 each be eligible for issuance of an immigrant visa or for  
2 adjustment of status to that of an alien lawfully admitted  
3 for permanent residence upon filing an application for is-  
4 suance of an immigrant visa under section 204 of such  
5 Act or for adjustment of status to lawful permanent resi-  
6 dent.

7 (b) ADJUSTMENT OF STATUS.—If Rosalba Colunga  
8 de Medina, Claudia Janet Alexandru Medina, and Jose  
9 Armando Medina, Jr., enters the United States before the  
10 filing deadline specified in subsection (c), he or she shall  
11 be considered to have entered and remained lawfully and  
12 shall, if otherwise eligible, be eligible for adjustment of  
13 status under section 245 of the Immigration and National-  
14 ity Act as of the date of the enactment of this Act.

15 (c) DEADLINE FOR APPLICATION AND PAYMENT OF  
16 FEES.—Subsections (a) and (b) shall apply only if the ap-  
17 plication for issuance of an immigrant visa or the applica-  
18 tion for adjustment of status is filed with appropriate fees  
19 within 2 years after the date of the enactment of this Act.

20 (d) REDUCTION OF IMMIGRANT VISA NUMBER.—  
21 Upon the granting of an immigrant visa or permanent res-  
22 idence to Rosalba Colunga de Medina, Claudia Janet  
23 Alexandru Medina, and Jose Armando Medina, Jr., the  
24 Secretary of State shall instruct the proper officer to re-  
25 duce by 3, during the current or next following fiscal year,

1 the total number of immigrant visas that are made avail-  
2 able to natives of the country of the aliens' birth under  
3 section 203(a) of the Immigration and Nationality Act or,  
4 if applicable, the total number of immigrant visas that are  
5 made available to natives of the country of the aliens' birth  
6 under section 202(e) of such Act.
