# **TITLE I—MISCELLANEOUS**

## **TRADE CORRECTIONS**

### **SEC. 101. REVIEW OF PROTESTS AGAINST DECISIONS OF CUSTOMS SERVICE.**

(a) IN GENERAL.—Section 515(a) of the Tariff Act of 1930 (19 U.S.C. 1515(a)) is amended by inserting after the third sentence the following: “Within 30 days from the date an application for further review is filed, the appropriate customs officer shall allow or deny the application and, if allowed, the protest shall be forwarded to the customs officer who will be conducting the further review.”.

(b) EFFECTIVE DATE.—The amendment made by subsection (a) shall apply with respect to applications for further review filed on or after the date of the enactment of this Act.

1 **SEC. 102. FINISHED PETROLEUM DERIVATIVES DRAWBACK.**

2       The Secretary of the Treasury shall convene a work-  
3 ing group of interested parties and, not later than March  
4 31, 1998, publish regulations and, if necessary, submit  
5 legislation to the Congress, to modify and simplify the  
6 processing of finished petroleum derivatives drawback  
7 claims.

8 **SEC. 103. DRAWBACK AND REFUND OF PACKAGING MATE-**  
9 **RIAL.**

10       (a) IN GENERAL.—Section 313(q) of the Tariff Act  
11 of 1930 (19 U.S.C. 1313(q)), as amended by this Act, is  
12 further amended—

13           (1) by striking “Packaging material” and in-  
14 serting the following:

15           “(1) IN GENERAL.—Packaging material”; and

16           (2) by adding at the end the following:

17           “(2) ADDITIONAL ELIGIBILITY.—Packaging  
18 material produced in the United States, which is  
19 used by the manufacturer or any other person on or  
20 for articles which are exported or destroyed under  
21 subsection (a) or (b), shall be eligible under such  
22 subsection for refund, as drawback, of 99 percent of  
23 any duty, tax, or fee imposed on the importation of  
24 such material used to manufacture or produce the  
25 packaging material.”.

1 (b) EFFECTIVE DATE.—The amendment made by  
2 this section applies with respect to goods entered, or with-  
3 drawn from warehouse for consumption, on or after the  
4 15th day after the date of the enactment of this Act.

9 (a) IN GENERAL.—Section 411 of the Tariff Act of  
10 1930 (19 U.S.C. 1411) is amended by adding at the end  
11 the following:

12 “(c) FOREIGN-TRADE ZONES.—Not later than Janu-  
13 ary 1, 1999, the Secretary shall provide for the inclusion  
14 of commercial importation data from foreign-trade zones  
15 under the Program.”.

16 (b) EFFECTIVE DATE.—The amendment made by  
17 this section shall take effect on the date of the enactment  
18 of this Act.

19 **SEC. 105. TREATMENT OF INTERNATIONAL TRAVEL MER-**

22 (a) IN GENERAL.—Section 557(a)(1) of the Tariff

24 first sentence by inserting “(including international travel  
25 merchandise)” after “Any merchandise subject to duty”.

1 (b) EFFECTIVE DATE.—The amendment made by  
 2 this section applies with respect to goods entered, or with-  
 3 drawn from warehouse for consumption, on or after the  
 4 15th day after the date of the enactment of this Act.

5 **SEC. 106. ENTRIES OF NAFTA-ORIGIN GOODS.**

6 (a) REFUND OF MERCHANDISE PROCESSING  
 7 FEES.—Section 520(d) of the Tariff Act of 1930 (19  
 8 U.S.C. 1520(d)) is amended in the matter preceding para-  
 9 graph (1) by inserting “(including any merchandise proc-  
 10 essing fees)” after “excess duties”.

 2           other provision of law, the aggregate of overtime pay  
 3           under subsection (a) of this section (including com-  
 4           muting compensation under subsection (a)(2)(B) of  
 5           this section) and premium pay under subsection (b)  
 6           of this section that a customs officer may be paid in  
 7           any fiscal year may not exceed \$25,000; except that  
 8           the Commissioner of Customs or his designee may  
 9           waive this limitation in individual cases in order to  
 10          prevent excessive costs or to meet emergency re-  
 11          quirements of the Customs Service.”.
