## A BILL

- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Redwood Parks Coop-
- 5 erative Management Act of 1996".
- 6 SEC. 2. COOPERATIVE MANAGEMENT OF STATE AND FED-
- 7 ERAL PARK LANDS AT REDWOOD NATIONAL
- 8 PARK.
- 9 (a) Cooperative Agreements.—Section 3(a) of
- 10 Public Law 90–545, entitled "An Act to establish a Red-
- 11 wood National Park in the State of California, and for
- 12 other purposes" (16 U.S.C. 79c), is amended by inserting
- 13 "(1)" after "Sec. 3. (a)", and by adding at the end the
- 14 following new paragraph:
- 15 "(2) The Secretary may enter into agreements with
- 16 the State of California to acquire from and provide to the
- 17 State goods and services to be used by the National Park
- 18 Service or the State of California, respectively, in the coop-
- 19 erative management of lands in Redwood National Park
- 20 and lands in Del Norte Coast Redwoods State Park,
- 21 Jedediah Smith Redwoods State Park, and Prairie Creek
- 22 Redwoods State Park, if the Secretary determines that ap-
- 23 propriations for that purpose are available and the agree-
- 24 ment is in the best interests of the United States.".

- 1 (b) Period of Assignments of State and Fed-
- 2 ERAL PERSONNEL.—Section 3(a) of that Act (16 U.S.C.
- 3 79c(a)) is further amended by adding at the end the fol-
- 4 lowing new paragraph:
- 5 "(3) Notwithstanding any other provision of law, an
- 6 assignment arranged by the Secretary under section 3372
- 7 of title 5, United States Code, of a Federal or State em-
- 8 ployee for work at Redwood National Park, or an exten-
- 9 sion of such an assignment, may be for any period of time
- 10 determined by the Secretary and the State of California
- 11 to be mutually beneficial.".
- 12 (c) Modification of Reporting Requirement.—
- 13 Section 3(c) of such Act (16 U.S.C. 79c(e)) is amended
- 14 by striking the third sentence and inserting the following:
- 15 "The Secretary shall submit an annual written report to
- 16 the Congress by January 31 of each year which describes
- 17 the contracts and cooperative agreements entered into in
- 18 the previous year under this subsection.".
- 19 (d) Updating of Maps.—Section 2(a) of such Act
- 20 (16 U.S.C. 79b(a)) is amended by striking "the maps enti-
- 21 tled" and all that follows through "March 1978" and in-
- 22 serting "the maps entitled 167–60501a and dated April
- 23 1996".
