A BILL

To repeal certain Federal education programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Clean Books Act”.

5 **SEC. 2. FINDINGS; PURPOSE.**

6 (a) FINDINGS.—Congress finds the following:

7 (1) The Federal Government administers sev-
8 eral hundred education programs annually. Of these

1 education programs, more than 100 programs are
2 unfunded.

3 (2) The President has not requested funding
4 for more than 50 such unfunded education programs
5 nor were such programs funded in the 103rd or
6 104th Congress.

7 (b) PURPOSE.—The purpose of this Act is to help
8 streamline bookkeeping for the Department of Education
9 by eliminating 69 of the existing unfunded education pro-
10 grams.

11 **SEC. 3. REPEAL OF CERTAIN UNFUNDED EDUCATION PRO-**
12 **GRAMS.**
