A BILL

To amend the Social Security Act to improve the information made available in social security account statements and to provide for annual distribution of such statements to beneficiaries.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Social Security Access
- 5 to Information Act of 1997".

1	SEC. 2. ANNUAL SOCIAL SECURITY ACCOUNT STATEMENTS
2	TO BENEFICIARIES INDICATING TOTAL BENE-
3	FITS PAID.
4	Section 1143 of the Social Security Act (42 U.S.C.
5	1320b-13) is amended—
6	(1) in subsection (a)(1), by striking "Beginning
7	not later than October 1, 1990, the Secretary" and
8	inserting "The Commissioner of Social Security";
9	(2) in subsection (a)(2), by redesignating sub-
10	paragraphs (B), (C), and (D), as subparagraphs
11	(C), (D), and (E), respectively, and by inserting
12	after subparagraph (A) the following new subpara-
13	graph:
14	"(B) the total amount of benefits paid as of the
15	date of the request to the eligible individual and the
16	total amount of benefits paid as of such date to all
17	beneficiaries on the basis of the eligible individual's
18	wages and self-employment income;";
19	(3) by adding at the end of subsection $(a)(2)$,
20	after and below subparagraph (E) (as redesignated),
21	the following new sentence:
22	"Dollar amounts specified pursuant to subparagraphs (A),
23	(B), (C), and (D) shall be expressed in terms of actual
24	dollars and in terms of surrent dollars ", and

- 1 (4) in subsection (c), by striking "(c)(1) By not
- 2 later" and all that follows through "appropriate." in
- 3 paragraph (2) and inserting the following:
- 4 "(c) Beginning not later than October 1, 1998, the
- 5 Commissioner of Social Security shall provide a statement
- 6 on an annual basis to each eligible individual for whom
- 7 a current mailing address can be determined through such
- 8 methods as the Commissioner determines to be appro-
- 9 priate.".

10 SEC. 3. EFFECTIVE DATE.

- 11 The amendments made by this Act shall apply with
- 12 respect to social security account statements provided
- 13 after September 30, 1998, and before October 1, 2018.
