A BILL

To authorize the President to award a gold medal on behalf of the Congress honoring Wilma G. Rudolph in recognition of her enduring contributions to humanity and women's athletics in the United States and the world.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. FINDINGS.

2	The Congress finds that—
3	(1) Wilma G. Rudolph of Clarksville, Ten-
4	nessee, the 20th of 22 children, overcame a series of
5	childhood diseases, including scarlet fever, double
6	pneumonia, and polio, to become an athletic pioneer
7	and champion in the State of Tennessee, the United
8	States, and the world, first as an outstanding bas-
9	ketball player and track athlete in Tennessee, then
10	as a three-time gold medal winner in the 1960
11	Olympics in Rome, and finally as a pioneer for racial
12	equality, goodwill, and justice;
13	(2) Wilma G. Rudolph's winning of 3 gold med-
14	als in the 1960 Olympics served as an inspiration to
15	athletes of all sports, races, and genders;
16	(3) Wilma G. Rudolph's ability to inspire en-
17	dured after her performance in the 1960 Olympics,
18	as demonstrated by—
19	(A) her receipt in 1987 of the National
20	Collegiate Athletic Association's Silver Anniver-
21	sary Award, the first time a woman ever re-
22	ceived the award;
23	(B) her receipt of the 1989 Jackie Robin-
24	son Image Award of the National Association
25	for the Advancement of Colored People
26	(NAACP);

1	(C) her induction into the National Track
2	and Field Hall of Fame in 1973;
3	(D) her receipt of the 1985 Humanitarian
4	of the Year Award of the Special Olympics; and
5	(E) her receipt in 1993 of the National
6	Sports Award from President William J. Clin-
7	ton, the only time a woman has received the
8	award;
9	(4) Wilma G. Rudolph, a graduate of Tennessee
10	State University, a successful businessperson, a
11	mother, an athlete, a coach, and a teacher, who
12	passed away on November 12, 1994, will forever re-
13	main an inspiration to all able-bodied and physically
14	challenged individuals in overcoming odds;
15	(5) Wilma G. Rudolph blazed a trail that
16	helped all people understand the contributions of
17	women to the world of athletics;
18	(6) Wilma G. Rudolph set the stage for the en-
19	actment of title IX of the Education Amendments of
20	1972, which prohibits sex discrimination in edu-
21	cation programs receiving Federal assistance, and
22	which has led to increased participation in athletics
23	by women and more career options for women in the

United States;

- 1 (7) the legacy of Wilma G. Rudolph continues
- 2 to serve as a particular inspiration to women who,
- 3 25 years after the enactment of title IX of the Edu-
- 4 cation Amendments of 1972, are able to reap the
- 5 benefits of increased access to athletics; and
- 6 (8) Wilma G. Rudolph's life truly embodied the
- 7 American values of hard work, determination, and
- 8 love of humanity.

9 SEC. 2. CONGRESSIONAL GOLD MEDAL.

- 10 (a) Presentation Authorized.—The President is
- 11 authorized to award, on behalf of the Congress, a gold
- 12 medal of appropriate design honoring Wilma G. Rudolph
- 13 in recognition of her outstanding and enduring contribu-
- 14 tions to humanity and to women's athletics in the United
- 15 States and the world.
- 16 (b) Design and Striking.—For the purpose of the
- 17 award referred to in subsection (a), the Secretary of the
- 18 Treasury (in this Act referred to as the "Secretary") shall
- 19 strike a gold medal with suitable emblems, devices, and
- 20 inscriptions, to be determined by the Secretary.

21 SEC. 3. DUPLICATE MEDALS.

- The Secretary may strike and sell duplicates in
- 23 bronze of the gold medal struck pursuant to section 2
- 24 under such regulations as the Secretary may prescribe,
- 25 and at a price sufficient to cover the costs thereof, includ-

- 1 ing labor, materials, dies, use of machinery, and overhead
- 2 expenses, and the cost of the gold medal.

3 SEC. 4. STATUS AS NATIONAL MEDALS.

- 4 The medals struck pursuant to this Act are national
- 5 medals for purposes of chapter 51 of title 31, United
- 6 States Code.

7 SEC. 5. FUNDING.

- 8 (a) AUTHORITY TO USE FUND AMOUNTS.—There is
- 9 authorized to be charged against the United States Mint
- 10 Public Enterprise Fund an amount not to exceed \$30,000
- 11 to pay for the cost of the medals authorized by this Act.
- 12 (b) PROCEEDS OF SALE.—Amounts received from the
- 13 sale of duplicate bronze medals under section 3 shall be
- 14 deposited in the United States Mint Public Enterprise
- 15 Fund.
