A BILL

To amend the Public Buildings Act of 1959 to improve the management and operations of the General Services Administration.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "General Services Ad-
- 5 ministration Improvement Act of 1997".
- 6 SEC. 2. PROSPECTUS REQUIREMENTS FOR COURTHOUSES.
- 7 (a) REQUIRED INFORMATION.—Section 7(a) of the
- 8 Public Buildings Act of 1959 (40 U.S.C. 606(a)) is
- 9 amended—

1	(1) by striking "and" at the end of paragraph
2	(5);
3	(2) by striking the period at the end of para-
4	graph (6) and inserting "; and; and
5	(3) by adding at the end the following:
6	"(7) with respect to any project for the design
7	or construction of a United States courthouse—
8	"(A) information concerning courtroom
9	utilization in the courthouse that is providing
10	facilities that will be provided in the proposed
11	courthouse;
12	"(B) information concerning anticipated
13	courtroom utilization in the proposed court-
14	house;
15	"(C) information concerning anticipated
16	facilities sharing in the proposed courthouse;
17	and
18	"(D) an analysis of whether the project
19	conforms to the United States Court Design
20	Guide.".
21	(b) Transmittal of Design Guide.—Section 7 of
22	the Public Buildings Act of 1959 (40 U.S.C. 606) is
23	amended by adding at the end the following:
24	"(g) Transmittal of Design Guide.—On an an-
25	nual basis, the Administrator shall obtain from the Ad-

- 1 ministrative Office of the United States Courts, and shall
- 2 transmit to Congress, the United States Court Design
- 3 Guide, including any revisions to the Guide. Together with
- 4 each Guide, the Administrator shall also transmit a report
- 5 containing a statement by the Administrator as to the ef-
- 6 fects of any revisions to the Guide on courthouse construc-
- 7 tion costs and such other information as the Adminis-
- 8 trator considers appropriate.".
- 9 SEC. 3. ACQUISITIONS OF PUBLIC BUILDINGS AND SITES
- 10 **BY EXCHANGE.**
- 11 Section 13 of the Public Buildings Act of 1959 (40
- 12 U.S.C. 612) is amended by adding at the end the follow-
- 13 ing:
- 14 "(8) The term 'exchange' includes an exchange for
- 15 future rights or benefits, including rights or benefits relat-
- 16 ing to the development of real property.".
- 17 SEC. 4. PROCEEDS FROM SALES AND LEASES.
- The Public Buildings Act of 1959 (40 U.S.C. 601
- 19 et seq.) is amended by adding at the end the following:
- 20 "SEC. 22. PROCEEDS FROM SALES AND LEASES.
- 21 "(a) Deposit Into Federal Buildings Fund.—
- 22 Notwithstanding any other provision of law, all proceeds
- 23 received after the date of the enactment of this section
- 24 from the sale of interests in real property, including build-
- 25 ings and other improvements thereto, controlled by the

- 1 Administrator and from the leasing of space in public
- 2 buildings located on such real property to private entities
- 3 shall be deposited into the Federal Buildings Fund estab-
- 4 lished by section 210(f) of the Federal Property and Ad-
- 5 ministrative Services Act of 1949 (40 U.S.C. 490(f)).
- 6 "(b) AVAILABILITY OF AMOUNTS.—Moneys deposited
- 7 into the Federal Buildings Fund pursuant to subsection
- 8 (a) shall be available only for expenditure for repair and
- 9 alteration activities and construction and acquisition of fa-
- 10 cilities activities in such amounts as are specified in an-
- 11 nual appropriations Acts without regard to fiscal year lim-
- 12 itations.".
