A BILL

To award a congressional gold medal to Francis Albert Sinatra.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. CONGRESSIONAL GOLD MEDAL.
- 4 (a) Presentation Authorized.—The President is
- 5 authorized to present, on behalf of the Congress, to
- 6 Francis Albert "Frank" Sinatra a gold medal of appro-
- 7 priate design, in recognition of his accomplishments as an
- 8 entertainer and humanitarian, which include—

- 1 (1) having a career in the entertainment indus-
- 2 try spanning 5 decades where he produced, directed,
- 3 or appeared in more than 50 motion pictures, re-
- 4 corded thousands of songs with annual sales num-
- bering in the millions, and won many major awards
- 6 in American popular entertainment including 7
- 7 Grammys, a Peabody, an Emmy and a Best Sup-
- 8 porting Actor Oscar; and
- 9 (2) earning the Life Achievement Award of the
- 10 NAACP, the Academy of Motion Picture Arts and
- 11 Sciences' Jean Hersholt Humanitarian Award, and
- the Presidential Medal of Freedom for his humani-
- tarian and social justice efforts.
- 14 (b) Design and Striking.—For purposes of the
- 15 presentation referred to in subsection (a), the Secretary
- 16 of the Treasury shall strike a gold medal with suitable em-
- 17 blems, devices, and inscriptions to be determined by the
- 18 Secretary.
- 19 (c) AUTHORIZATION OF APPROPRIATION.—There are
- 20 authorized to be appropriated not to exceed \$30,000 to
- 21 carry out this section.
- 22 SEC. 2. DUPLICATE MEDALS.
- 23 (a) STRIKING AND SALE.—The Secretary of the
- 24 Treasury may strike and sell duplicates in bronze of the

- 1 gold medal struck pursuant to section 1 under such regu-
- 2 lations as the Secretary may prescribe, at a price sufficient
- 3 to cover the cost thereof, including labor, materials, dies,
- 4 use of machinery, and overhead expenses, and the cost of
- 5 the gold medal.
- 6 (b) Reimbursement of Appropriation.—The ap-
- 7 propriation used to carry out section 1 shall be reimbursed
- 8 out of the proceeds of sales under subsection (a).
- 9 SEC. 3. NATIONAL MEDALS.
- The medals struck pursuant to this Act are national
- 11 medals for purposes of chapter 51 of title 31, United
- 12 States Code.
