## A BILL

To consolidate in a single independent agency in the executive branch the responsibilities regarding food safety, labeling, and inspection currently divided among several Federal agencies.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Safe Food Act of
- 5 1997".

### 1 SEC. 2. PURPOSES.

2	It is the purpose of this Act—

5	ing and to conduct food safety inspections to ensure,
6	with reasonable certainty, that no harm will result
7	from the consumption of food by preventing food-
8	borne illnesses due to microbial, natural, or chemical
9	hazards in food; and

11	tion the food safety, labeling, and inspection func-
12	tions currently performed by other Federal agencies.

13	SEC. 4. ESTABLISHMENT OF INDEPENDENT FOOD SAFETY

1	SEC. 5. CONSOLIDATION OF SEPARATE FOOD SAFETY AND
2	INSPECTION SERVICES AND AGENCIES.
3	(a) TERMINATION.—As soon as possible after the ef-
4	fective date of this Act, the President shall terminate the
5	Federal agencies specified in subsection (b) to the extent
6	that the activities of such agencies relate to the adminis-
7	tration or enforcement of the food safety laws.
8	(b) Covered Agencies.—The Federal agencies re-
9	ferred to in subsection (a) are the following:
10	(1) The Food Safety and Inspection Service of
11	the Department of Agriculture.
12	(2) The Center for Food Safety and Applied
13	Nutrition of the Food and Drug Administration.
14	(3) The Center for Veterinary Medicine of the
15	Food and Drug Administration.
16	(4) The National Marine Fisheries Service of
17	the National Oceanic and Atmospheric Administra-
18	tion of the Department of Commerce.
19	(5) The Office of Pesticide Programs under the
20	Assistant Administrator of the Environmental Pro-
21	tection Agency for Prevention, Pesticides, and Toxic
22	Substances.
23	(6) Such other offices, services, or agencies as
24	the President may designate to further the purposes
25	of this Act.

- 1 (c) Transfer of Assets and Funds.—Consistent
- 2 with section 1531 of title 31, United States Code, the per-
- 3 sonnel, assets, liabilities, contracts, property, records, and
- 4 unexpended balances of appropriations, authorizations, al-
- 5 locations, and other funds of a Federal agency terminated
- 6 in whole or in part under subsection (a) that are used in
- 7 connection with the administration or enforcement of the
- 8 food safety laws shall be transferred to the Administration
- 9 upon the termination of the Federal agency. Unexpended
- 10 funds transferred pursuant to this subsection shall be used
- 11 by the Administration only for the purposes for which the
- 12 funds were originally authorized and appropriated.
- 13 (d) References.—After the termination of a Fed-
- 14 eral agency under subsection (a), any reference in any
- 15 other Federal law, Executive order, rule, regulation, docu-
- 16 ment, or other material to that Federal agency or the head
- 17 of that agency in connection with the administration or
- 18 enforcement of the food safety laws shall be deemed to
- 19 be a reference to the Administration.
- 20 (e) Savings Provisions.—The termination of a
- 21 Federal agency under subsection (a) shall not affect—
- 22 (1) an order, determination, rule, regulation,
- permit, agreement, grant, contract, certificate, li-
- cense, registration, privilege, or other administrative
- action issued, made, granted, or otherwise in effect

1	with respect to that agency before the termination
2	date regarding functions transferred to the Adminis-
3	tration under this Act;
4	(2) any suit commenced before the termination
5	of that agency, any other proceeding (including a
6	notice of proposed rulemaking), or any application
7	for any license, permit, certificate, or financial as-
8	sistance pending before that agency with respect to
9	functions transferred to the Administration under
10	this Act.
11	SEC. 6. LIMITATION ON AUTHORIZATION OF APPROPRIA-
12	TIONS.
13	For the first fiscal year beginning after the date of
14	the enactment of this Act, the amount authorized to be
15	appropriated to carry out this Act shall not exceed the
16	amount appropriated for fiscal year 1998 for the Federal
17	agencies to be terminated under section 5(a) to administer
18	the food safety laws.
19	SEC. 7. EFFECTIVE DATE.
20	This Act shall take effect on the earlier of—
21	(1) the date that is 180 days after the date of
22	the enactment of this Act; and
23	(2) such date during that 180-day period as the

President may direct in an Executive order.
