A BILL

To protect the constitutional right to travel to foreign countries.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Freedom to Travel
- 5 Act of 1997".
- 6 SEC. 2. TRAVEL TO FOREIGN COUNTRIES.
- 7 (a) Freedom of Travel for United States Citi-
- 8 ZENS AND LEGAL RESIDENTS.—The President shall not
- 9 restrict travel abroad by United States citizens or legal
- 10 residents, except to countries with which the United States
- 11 is at war, where armed hostilities are in progress, or where

- "(E) normal banking transactions incident to the activities described in the preceding provisions of this paragraph, including the issuance, clearing, processing, or payment of checks, drafts, travelers checks, credit or debit card instruments, or similar instruments;
- except that this paragraph does not authorize the importation into the United States of any goods for personal consumption acquired in another country other than those items described in paragraphs (1) and (3); or".
- 15 (c) AMENDMENTS TO TRADING WITH THE ENEMY 16 ACT.—Section 5(b) of the Trading With the Enemy Act 17 (50 U.S.C. App. 5(b)) is amended by adding at the end
- 18 the following new paragraph:
- 19 "(5) The authority granted by the President in this
- 20 section does not include the authority to regulate or pro-
- 21 hibit, directly or indirectly, any of the following trans-
- 22 actions incident to travel by individuals who are citizens
- 23 or residents of the United States:
- 24 "(A) Any transactions ordinarily incident to
- 25 travel to or from any country, including importation

- into a country or the United States of accompanied
 baggage for personal use only.
- "(B) Any transactions ordinarily incident to travel or maintenance within any country, including the payment of living expenses and the acquisition of goods or services for personal use.
 - "(C) Any transactions ordinarily incident to the arrangement, promotion, or facilitation of travel to, from, or within a country.
 - "(D) Any transactions incident to nonscheduled air, sea, or land voyages, except that this subparagraph does not authorize the carriage of articles into a country except accompanied baggage.
 - "(E) Normal banking transactions incident to the activities described in the preceding provisions of this paragraph, including the issuance, clearing, processing, or payment of checks, drafts, travelers checks, credit or debit card instruments, negotiable instruments, or similar instruments.
- 20 This paragraph does not authorize the importation into
- 21 the United States of any goods for personal consumption
- 22 acquired in another country other than those items de-
- 23 scribed in paragraph (4).".

- 4 ties conferred upon the President by section 5(b) of the
- 5 Trading With the Enemy Act, which were being exercised
- 6 with respect to a country on July 1, 1977, as a result
- 7 of a national emergency declared by the President before
- 8 such date, and are being exercised on the date of the en-
- 9 actment of this Act, do not include the authority to regu-
- 10 late or prohibit, directly or indirectly, any activity which
- 11 under section 5(b) (5) or (6) of the Trading With the
- 12 Enemy Act (as added by this Act) may not be regulated
- 13 or prohibited.
- 14 SEC. 5. INAPPLICABILITY OF OTHER PROVISIONS.
- 15 This Act and the amendments made by this Act apply
- 16 notwithstanding section 102(h) of the Cuban Liberty and
- 17 Democratic Solidarity (LIBERTAD) Act of 1996.
