To amend the Balanced Budget Act of 1997 to reinstate payment under medicare for home health services consisting of venipuncture solely for the purpose of obtaining a blood sample, and to require the Secretary of Health and Human Services to study potential fraud and abuse under the medicare program with respect to such services.

A BILL

To amend the Balanced Budget Act of 1997 to reinstate payment under Medicare for home health services consisting of venipuncture solely for the purpose of obtaining a blood sample, and to require the Secretary of Health and Human Services to study potential fraud and abuse under the Medicare Program with respect to such services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Medicare Venipuncture
3	Fairness Act of 1997".

- 4 SEC. 2. REPEAL OF PROHIBITION ON PAYMENT FOR HOME
- 5 HEALTH SERVICES SOLELY FOR PURPOSES
- 6 OF OBTAINING A BLOOD SAMPLE; REPORT.
- 7 (a) Repeal.—Section 4615 of the Balanced Budget
- 8 Act of 1997 is hereby repealed.
- 9 (b) Report to Congress.—The Balanced Budget
- 10 Act of 1997, as amended in subsection (a), is further
- 11 amended by inserting after section 4614, the following
- 12 new section:
- 13 "SEC. 4615. REPORT TO CONGRESS ON HOME HEALTH BEN-
- 14 EFITS BASED SOLELY ON DRAWING BLOOD.
- 15 "(a) STUDY.—The Secretary of Health and Human
- 16 Services shall conduct a study with respect to the provision
- 17 of home health services consisting of venipuncture under
- 18 title XVIII of the Social Security Act. In conducting such
- 19 study, the Secretary, using the most recent data available,
- 20 shall—
- 21 "(1) determine the number of beneficiaries who
- are provided home health services under the medi-
- care program;
- 24 "(2) determine the number of beneficiaries who
- 25 receive such services consisting of venipuncture;

1 "(3) compare the instances in which the only 2 home health service provided in a home health visit 3 is venipuncture solely for the purposes of obtaining 4 blood sample and those instances in which 5 venipuncture is provided in such a visit in conjunc-6 tion with the provision of other home health services; "(4) determine the costs of providing payment 7 8 for home health services consisting of venipuncture 9 solely for the purpose of obtaining a blood sample, 10 including in such determination an analysis of the 11 increase in such costs attributable to fraud and 12 abuse in the provision of or billing for such services 13 under the medicare program; and 14 "(5) determine— "(A) the costs to beneficiaries if payment 15 16 under the medicare program is prohibited for 17 home health services consisting of venipuncture 18 solely for the purposes of obtaining a blood 19 sample, and "(B) the costs to States through poten-20 21 tially increased use of personal care services 22 and nursing home placements under the re-23 duced program due to such prohibition. "(b) REPORT.—Not later than 1 year after the date 24

of the enactment of this Act, the Secretary shall submit

- 1 to Congress a report consisting of the findings of the study
- 2 conducted under subsection (a).".
- 3 (c) CLERICAL AMENDMENT.—The item relating to
- 4 section 4615 in the table of contents of title IV of the
- 5 Balanced Budget Act of 1997 is amended to read as fol-
- 6 lows:

"Sec. 4615. Report to Congress on home health benefits based solely on drawing blood.".

- 7 (d) Effective Date.—The amendments made by
- 8 this section take effect as if included in the enactment of
- 9 the Balanced Budget Act of 1997.
