A BILL

To require recreational camps to report information concerning deaths and certain injuries and illnesses to the Secretary of Health and Human Services, to direct the Secretary to collect the information in a central data system, to establish a President's Advisory Council on Recreational Camps, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Recreational Camp
- 5 Safety Act".

1 SEC. 2. DEFINITIONS.

2	For purposes of this Act:
3	(1) Camper.—The term "camper" means an
4	individual who is attending a recreational camp
5	and—
6	(A) is less than 18 years of age; or
7	(B) is an individual with special needs.
8	(2) COUNCIL.—The term "Council" means the
9	President's Advisory Council on Recreational Camps
10	established by section 201.
11	(3) Day camp.—The term "day camp" means
12	a camp that is operated on a permanent campsite
13	for less than 24 hours a day and for at least 5 days
14	during a 2-week period, but does not include—
15	(A) a swimming facility operated by a pub-
16	lic agency or a private organization on a mem-
17	bership basis, to the extent that the facility is
18	not used as part of a recreational camp;
19	(B) a day care center, to the extent that
20	the center is not used as part of a recreational
21	camp; or
22	(C) a playground or other recreational fa-
23	cility provided for neighborhood use by a local
24	public agency.

1	(4) Individual with special needs.—The
2	term "individual with special needs" means an indi-
3	vidual who has a physical or mental impairment that
4	substantially limits 1 or more of the individual's
5	major life activities.
6	(5) Medical incident.—The term "medical
7	incident" means—
8	(A) a death of a camper, staff member,
9	recreational camp operator, or recreational
10	camp director; or
11	(B) an injury or illness of such an individ-
12	ual that—
13	(i) is treated by a physician or nurse;
14	and
15	(ii) results in the affected individual—
16	(I) returning to the individual's
17	permanent residence from a residen-
18	tial camp;
19	(II) being admitted to a hospital;
20	or
21	(III) having a laboratory analysis
22	or X-ray performed that results in a
23	positive diagnosis.
24	(6) Nonprofit.—The term "nonprofit", when
25	used with respect to a person, means a person—

1	(A) described in section $501(c)(3)$ of the
2	Internal Revenue Code of 1986 (26 U.S.C.
3	501(c); and
4	(B) exempt from taxation under section
5	501(a) of such Code (26 U.S.C. 501(a)).
6	(7) Permanent campsite.—The term "per-
7	manent campsite" means a premises that is continu-
8	ously or periodically used for camping purposes by
9	a recreational camp operator.
10	(8) Recreational camp.—The term "rec-
11	reational camp" means a day camp, residential
12	camp, travel camp, or trip camp located on private
13	or public land that—
14	(A) is conducted for 10 or more campers;
15	(B) offers recreational camp activities that
16	are conducted under the auspices of a rec-
17	reational camp operator or recreational camp
18	director; and
19	(C) is owned or operated by a recreational
20	camp operator.
21	(9) Recreational camp activities.—The
22	term "recreational camp activities" includes swim-
23	ming, diving, boating, lifesaving, canoeing, sailing,
24	skindiving, archery, riflery, horseback riding, hiking,

- tennis, mountain climbing, other sports and athletics, camperaft, and nature study activities.
- term "recreational camp director" means the individual on the premises of a recreational camp who has the primary responsibility for the administration of program operations and support services for the camp and for the supervision of the staff members of the camp.
 - (11) Recreational camp operator" means a person or governmental agency who owns or operates a recreational camp, regardless of whether the camp is nonprofit.
 - (12) RESIDENTIAL CAMP.—The term "residential camp" means a camp that is operated on a permanent campsite 24 hours a day for 4 or more days.
 - (13) Secretary.—The term "Secretary" means the Secretary of Health and Human Services.
 - (14) SEXUAL ABUSE.—The term "sexual abuse" has the meaning given such term in section 226(c) of the Crime Control Act of 1990 (42 U.S.C. 13031).

- 1 (15) STAFF MEMBER.—The term "staff mem2 ber" means an individual who is employed by a rec3 reational camp operator to supervise, direct, or con4 trol recreational camp activities, regardless of wheth5 er the individual is compensated for the individual's
 6 services.
 - (16) STATE.—The term "State" means any of the several States, the District of Columbia, the Virgin Islands, the Commonwealth of Puerto Rico, Guam, and American Samoa.
 - (17) Travel camp.—The term "travel camp" means a camp that is operated 24 hours a day over a period of 2 or more days and that uses motorized transportation to move campers as a group from 1 site to another.
 - (18) Trip camp.—The term "trip camp" means a camp that is operated 24 hours a day over a period of 2 or more days and that moves campers under their own power or by a transportation mode permitting individual guidance of a vehicle or animal from 1 site to another.

TITLE I—RECREATIONAL CAMP REQUIREMENTS REPORTING 2 AND DATA BASE 3 4 SEC. 101. RECREATIONAL CAMP REPORTING REQUIRE-5 MENTS. 6 (a) IN GENERAL.—A recreational camp in a State shall report to the Secretary of Health and Human Serv-7 8 ices— 9 (1) each medical incident that occurs at the 10 camp; and 11 (2) each incident of sexual abuse that— 12 (A) is alleged to have occurred at the 13 camp; 14 (B) is alleged to involve a camper or staff 15 member as a victim; and 16 (C) has previously been reported to an-17 other governmental agency. 18 (b) REPORTING OFFICIALS.—The recreational camp 19 director or recreational camp operator of the camp in-20 volved shall make the report required under subsection 21 (a). 22 (c) Timing.— 23 (1) Report of Medical Incident.—A medi-24 cal incident shall be reported to the Secretary within

1	the 7-day period beginning on the date of the occur-
2	rence of an event described in subparagraph (A), or
3	subclause (I), (II), or (III) of subparagraph (B)(ii),
4	of section $2(5)$.
5	(2) Report of Sexual abuse allegation.—
6	An allegation of sexual abuse shall be reported to
7	the Secretary within the 7-day period beginning on
8	the 1st date that the allegation is reported to a gov-
9	ernmental agency.
10	(d) Methods of Reporting.—
11	(1) Obligations of Camp.—The report re-
12	quired in subsection (a) shall be made by—
13	(A) verbally reporting to the Secretary,
14	through a toll-free, long-distance telephone line
15	provided by the Secretary, the information con-
16	cerning the incident that the Secretary may re-
17	quest; or
18	(B) mailing to the Secretary a written re-
19	port concerning the incident on a form pre-
20	scribed by the Secretary.
21	(2) Obligations of Secretary.—The Sec-
22	retary shall—
23	(A) establish the telephone line referred to
24	in paragraph (1)(A) and publish information on

access to the line in a manner that, to the ex-1 2 tent practicable, will notify recreational camp 3 operators of its availability; (B) consult with State agencies that have legal responsibility for public health under State 6 law in developing the form referred to in para-7 graph (1)(B); and 8 (C) prescribe the form referred to in para-9 graph (1)(B) and publish information on the 10 form in a manner that, to the extent practicable, will notify recreational camp operators 11 12 of its availability. SEC. 102. RECREATIONAL CAMP DATA BASE. 14 (a) In General.—The Secretary shall collect in a 15 central data system the information reported under section 101. The Secretary shall collect the information in 16 a manner that will enable the Secretary to compile sepa-18 rate statistics concerning incidents that involve— 19 (1) campers; and 20 (2) staff members, recreational camp operators, 21 and recreational camp directors. 22 (b) Annual Report.—Not later than December 31 23 of each year that occurs more than 2 years after the date of the enactment of this Act, the Secretary shall submit

to the President, the Congress, the National Association

1	of Governors, and the National Association of State Legis-
2	latures, a report setting forth a comprehensive analysis of
3	the information reported under section 101 during the
4	year.
5	(c) Advisories.—The Secretary shall evaluate on an
6	ongoing basis whether the incidents reported under section
7	101 could have been prevented through increased over-
8	sight or regulation of recreational camps or increased en-
9	forcement of laws applicable to recreational camps. At the
10	discretion of the Secretary, the Secretary may issue
11	advisories to States that will assist them in the prevention
12	of deaths, injuries, and illnesses at recreational camps.

15	pursuant to deadlines that the Secretary shall prescribe
16	by regulation.
17	(d) Maintenance at Camp.—A medical log re-
18	quired in subsection (a) shall remain at a recreational
19	camp during the hours of operation of the camp, except
20	the log may be removed for purposes of—
21	(1) transporting it to a physician, nurse, or
22	medical facility in the event of an emergency; or
23	(2) examination by the Secretary.

1	(e) Retention of Entries.—A recreational camp
2	may dispose of a portion of a medical log required in sub-
3	section (a) that contains only entries made in the log more
4	than 2 years before the date of disposal.
5	(f) Access.—The Secretary shall have access, for the
6	purpose of examination, to a medical log required in sub-
7	section (a). A State agency that has legal responsibility
8	for public health under the law of the State in which a
9	recreational camp is located shall also have access, for the
10	purpose of examination, to the medical log of the camp.
11	SEC. 104. ENFORCEMENT OF REPORTING AND RECORDING
12	REQUIREMENTS.
13	(a) In General.—If a recreational camp in a State
14	fails to comply with a requirement imposed on it by this
15	title, the Secretary shall advise of such failure—
16	(1) each State agency that has legal responsibil-

- 6 SEC. 105. EFFECTIVE DATE.
- 7 (a) In General.—Except as provided in subsection
- 8 (b), the provisions of this title shall take effect 1 year after

- 13 TITLE II—PRESIDENT'S ADVI-
- 14 SORY COUNCIL ON REC-
- 15 **REATIONAL CAMPS**
- 16 SEC. 201. ESTABLISHMENT.
- 17 There is established a council to be known as the
- 18 President's Advisory Council on Recreational Camps.
- 19 SEC. 202. DUTIES.
- 20 (a) In General.—The Council shall develop model
- 21 safety guidelines for recreational camps.
- 22 (b) Specific Issues.—In fulfilling the duty de-
- 23 scribed in subsection (a), the Council shall consider—
- 24 (1) qualifications for recreational camp direc-
- tors, staff members, and health personnel;

1 (2) appropriate ratios of campers to staff mem-2 bers; 3 (3) fire and lightening safety; (4) housing and plumbing construction; (5) waterfront safety; 6 (6) written fire and safety plans; 7 (7) special supervision and equipment for high-8 risk activities such as aquatics, riflery, archery, and 9 horseback riding; and 10 (8) special requirements for individuals with 11 special needs. 12 (c) STATE LAWS.—The Council shall study the laws 13 and guidelines of States concerning camp safety. 14 (d) NEED FOR FEDERAL LAW.—The Council shall 15 consider whether and by what means States could be encouraged to adopt the model safety guidelines developed 16 by the Council, including consideration of financial incentives. The Council shall formulate a recommendation con-19 cerning whether the guidelines should be incorporated in 20 Federal law. 21 SEC. 203. MEMBERSHIP. 22 (a) Number and Appointment.—The Council shall 23 be composed of 9 members appointed by the President.

The Council shall consist of the following members:

- (1) 1 individual from the general public who
 has a special interest in recreational camps;
 (2) 1 individual from a private nonprofit orga-
 - (2) 1 individual from a private nonprofit organization that operates a recreational camp for individuals with special needs;
- 6 (3) 1 individual from an organization that has 7 a special interest in safety;
- 8 (4) 2 recreational camp operators from non-9 profit recreational camps;
- 10 (5) 2 recreational camp operators from rec-11 reational camps that are not nonprofit; and
- 12 (6) 2 State officials who exercise responsibility 13 for recreational camp safety in their respective 14 States.
- 15 (b) Continuation of Membership.—Any individ-
- 16 ual appointed under subsection (a) who ceases to fulfill
- 17 the requirements contained in the paragraph under which
- 18 such individual was appointed because of a change in such
- 19 individual's status may continue as a member of the Coun-
- 20 cil for not longer than the 30-day period beginning on the
- 21 date of such change in status.
- (c) Terms.—Each member shall be appointed for the
- 23 life of the Council.

- 24 (d) VACANCIES.—A vacancy in the Council shall be
- 25 filled not later than 30 days after the date of the creation

- 1 of the vacancy in the manner in which the original ap-
- 2 pointment was made.
- 3 (e) Compensation.—
- 4 (1) Rates of Pay.—Except as provided in
- 5 paragraph (2), members of the Council shall serve
- 6 without pay.
- 7 (2) Travel expenses.—Each member of the
- 8 Council shall receive travel expenses, including per
- 9 diem in lieu of subsistence, in accordance with sec-
- tions 5702 and 5703 of title 5, United States Code.
- 11 (f) Quorum.—5 members of the Council shall con-
- 12 stitute a quorum, but a lesser number may hold hearings,
- 13 take testimony, or receive evidence.
- 14 (g) Chairperson.—The chairperson of the Council
- 15 shall be elected by a majority vote of the members of the
- 16 Council.
- 17 (h) Meetings.—The Council shall meet at the call
- 18 of a majority of the members of the Council.
- 19 SEC. 204. STAFF AND SUPPORT SERVICES.
- 20 (a) DIRECTOR.—The Council shall have a director
- 21 appointed by the Council and paid at a rate not to exceed
- 22 the minimum rate of basic pay payable for GS-13 of the
- 23 General Schedule.

- 1 (b) STAFF.—The Council may appoint and fix the
- 2 pay of additional personnel as it considers appropriate, ex-
- 3 cept that an individual so appointed may not receive pay
- 4 in excess of the maximum rate of basic pay payable for
- 5 GS-11 of the General Schedule.
- 6 (c) Applicability of Certain Civil Service
- 7 Laws.—The director and staff of the Council may be ap-
- 8 pointed without regard to the provisions of title 5, United
- 9 States Code, governing appointments in the competitive
- 10 service, and may be paid without regard to the provisions
- 11 of chapter 51 and subchapter III of chapter 53 of that
- 12 title relating to classification and General Schedule pay
- 13 rates, except as provided in subsections (a) and (b).
- 14 (d) Staff of Federal Agencies.—Upon request
- 15 of the Council, the head of any Federal agency may detail,
- 16 on a nonreimbursable basis, any of the personnel of the
- 17 agency to the Council to assist it in carrying out its duties
- 18 under this title.
- 19 (e) Experts and Consultants.—The Council may
- 20 procure temporary and intermittent services under section
- 21 3109(b) of title 5, United States Code, but at rates for
- 22 individuals not to exceed the daily equivalent of the mini-
- 23 mum annual rate of basic pay payable for GS-13 of the
- 24 General Schedule.

- 1 (f) Administrative Support Services.—The Ad-2 ministrator of General Services shall provide to the Coun-
- 3 cil on a reimbursable basis such administrative support
- 4 services necessary for the Council to carry out its respon-
- 5 sibilities under this title.

6 SEC. 205. POWERS.

- 7 (a) Hearings and Sessions.—The Council may, for
- 8 the purpose of carrying out this title, hold hearings, sit
- 9 and act at times and places, take testimony, and receive
- 10 evidence as the Council considers appropriate. The Council
- 11 may administer oaths or affirmations to witnesses appear-
- 12 ing before it.
- 13 (b) Delegation of Authority.—Any member or
- 14 agent of the Council may, if authorized by the Council,
- 15 take any action that the Council is authorized to take by
- 16 this section.

17 (c) Information.—

- 18 (1) In General.—The Council may secure di-
- 19 rectly from any Federal agency information nec-
- essary to enable it to carry out this title. Upon re-
- 21 quest of the Council, the head of the Federal agency
- shall furnish the information to the Council.
- 23 (2) Exception.—Paragraph (1) shall not
- apply to any information that the Council is prohib-
- ited to secure or request by another law.

- 1 (d) Mails.—The Council may use the United States
- 2 mails in the same manner and under the same conditions
- 3 as other Federal agencies.
- 4 (e) Contract Authority.—The Council may con-
- 5 tract with and compensate government and private agen-
- 6 cies or persons for supplies or services without regard to
- 7 section 3709 of the Revised Statutes (41 U.S.C. 5).
- 8 SEC. 206. REPORT.
- 9 Not later than the expiration of the 1-year period be-
- 10 ginning on the date of the appointment of the last member
- 11 of the Council to be appointed under section 203(a), the
- 12 Council shall submit to the President, the Congress, the
- 13 National Association of Governors, and the National Asso-
- 14 ciation of State Legislatures a final report containing the
- 15 model safety guidelines developed by the Council and the
- 16 other findings, conclusions, and recommendations of the
- 17 Council.
- 18 SEC. 207. TERMINATION.
- 19 The Council shall terminate not later than the expira-
- 20 tion of the 60-day period beginning on the date on which
- 21 the Commission submits its final report under section 206.
- 22 SEC. 208. BUDGET COMPLIANCE.
- 23 Any spending authority (as defined in subparagraphs
- 24 (A) and (C) of section 401(c)(2) of the Congressional
- 25 Budget Act of 1974 (2 U.S.C. 651(c)(2)(A))) authorized

- 1 by this title shall be effective only to such extent or in
- 2 such amounts as are provided in appropriation Acts.
