### SEC. 3. AUTHORITY OF THE PRESIDENT TO WITHHOLD THE

- 2 PAYMENT OF FUNDS.
- 3 (a) In General.—The President may withhold the
- 4 payment of any appropriated funds, authorized to be ap-
- 5 propriated by this Act, if the President determines that
- 6 the United Nations has failed to implement or to continue
- 7 to implement consensus-based decisionmaking procedures
- 8 on budgetary matters which assure that sufficient atten-
- 9 tion is paid to the views of the United States and other
- 10 member states that are the major financial contributors
- 11 to the United Nations.
- 12 (b) Notice to Congress.—The President shall no-
- 13 tify the Congress when a decision is made to withhold the
- 14 payment of funds pursuant to subsection (a) and shall no-
- 15 tify the Congress when the decision is made to pay any
- 16 funds previously withheld.
