A BILL

To direct the Administrator of the Environmental Protection Agency to design and implement a performance-based measurement system to encourage the development of new environmental monitoring technologies.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Less Pollution
- 5 Through Technology Act of 1997."
- 6 SEC. 2. FINDINGS AND PURPOSES.
- 7 (a) FINDINGS.—Congress finds the following:

- (1) The development of new and innovative environmental technologies, including technologies for monitoring environmental compliance, has been identified as a priority by the Environmental Protection Agency (referred to in this Act as the "Agency").
 - (2) Current Agency environmental monitoring requirements typically specify the use of a particular analytical method that must be precisely followed, including the use of specific procedures and instrumentation. These requirements inhibit introduction of new environmental monitoring technologies that could prove more accurate, reliable, and cost-effective because of time consuming and labor-intensive procedures for revising regulations.
 - (3) The Agency is evaluating the barriers to the introduction of new and innovative environmental monitoring technologies and has begun the transition of converting from the current analytical methods approach to a performance-based measurement system.
 - (b) Purposes.—The purposes of this Act are to—
 - (1) facilitate the development, introduction, and use of new and innovative environmental monitoring technologies through the conversion of the Agency's

- analytical methods to a performance-based measurement system; and
- (2) establish a deadline for the Agency to implement a performance-based measurement system
 to cover all media and multimedia environmental
 monitoring.

7 SEC. 3. DEFINITIONS.

- 8 For purposes of this Act:
- 9 (1) The term "Agency" means the Environ-10 mental Protection Agency.
 - (2) The term "Administrator" means the Administrator of the Environmental Protection Agency.
- 13 (3) The term "environmental monitoring tech-14 nologies" means procedures or techniques associated 15 with the performance, technical capability, or envi-16 ronmental impact of an analytical method.
 - (4) The term "performance-based measurement system" means a system that ensures environmental monitoring data quality assurance objectives are met, without prescribing particular procedures, techniques, or instrumentation for meeting such objectives.

23 SEC. 4. PERFORMANCE-BASED MEASUREMENT SYSTEM.

24 (a) ESTABLISHMENT.—(1) No later than 18 months 25 after the date of enactment of this Act, the Administrator

- 1 shall establish and begin implementing a performance-
- 2 based measurement system that will facilitate the use of
- 3 new environmental monitoring technologies, particularly
- 4 monitoring required to demonstrate compliance with laws
- 5 and regulations.
- 6 (2) Notwithstanding the implementation of a per-
- 7 formance-based measurement system, analytical methods
- 8 existing on the date of enactment of this Act shall be
- 9 deemed acceptable to the Administrator until such time
- 10 as the Administrator determines that such methods are
- 11 no longer acceptable.
- 12 (b) Construction.—Nothing in this Act shall be
- 13 construed to permit the Agency to devise or endorse a
- 14 process that permits or requires the rating or evaluation
- 15 of one technology or instrument over another. Nothing in
- 16 this Act shall be construed to require the approval of a
- 17 particular environmental technology or instrument.
- 18 (c) Status.—A performance-based measurement
- 19 system implemented pursuant to this section shall be
- 20 deemed to be equivalent to Agency analytical methods ex-
- 21 isting on the date of enactment of this Act for purposes
- 22 of compliance with all applicable environmental statutes
- 23 and regulations.

3	(a) Establishment.—The Administrator shall es-
4	tablish a Performance-Based Measurement System Advi-
5	sory Committee no later than 90 days after the date of

7	(b) Purposes.—The Performance-Based Measure-
8	ment System Advisory Committee shall—
9	(1) assist the Administrator in developing a
10	plan for implementation of a performance-based
11	measurement system;
12	(2) advise the Administrator regarding how
13	Agency policies, regulations, standards, and proce-
14	dures can be used to implement a performance-based
15	measurement system; and
16	(3) assist the Administrator in developing the

18	(c) Membership.—The Performance-Based Meas-
19	urement System Advisory Committee shall be comprised
20	of 12 members selected for appointment to provide a
21	broad and balanced representation of interested parties,
22	including the analytical instruments industry, environ-
23	mental testing laboratories, representatives from State
24	regulatory agencies, public interest groups, and profes-

25 sional or technical societies.

- 1 (d) Duration.—Section 14 of the Federal Advisory
- 2 Committee Act (5 U.S.C. App.) shall not apply with re-
- 3 spect to the duration of the advisory committee established
- 4 under this section.
- 5 (e) Duties.—The Performance-Based Measurement
- 6 System Advisory Committee shall convene at least twice
- 7 a year, and may meet at additional times as required by
- 8 the Administrator. The Performance-Based Measurement
- 9 System Advisory Committee shall submit to the Adminis-
- 10 trator such recommendations as it believes are consistent
- 11 with its purposes. The Administrator shall make available
- 12 to the Performance-Based Measurement System Advisory
- 13 Committee such staff as are necessary to carry out its pur-
- 14 poses.

15 SEC. 6. REPORT TO CONGRESS.

- No later than 6 months after the date of enactment
- 17 of this Act, the Administrator shall submit to Congress
- 18 a report containing a plan to establish a performance-
- 19 based measurement system approval process in accordance
- 20 with section 4.
