1	SECTION 1. MANDATORY MINIMUM SENTENCES FOR
2	BRINGING IN AND HARBORING CERTAIN
3	ALIENS.
4	Section 274(a)(1)(B) of the Immigration and Nation-
5	ality Act (8 U.S.C. 1324(a)(1)(B)) is amended to read as
6	follows:
7	"(B)(i) Except as provided in clauses (ii) and (iii),
8	a person who violates subparagraph (A) shall—
9	"(I) in the case of a violation of subparagraph
10	(A)(i) or (v)(I) or in the case of a violation of sub-
11	paragraph (A)(ii), (iii), or (iv) in which the offense
12	was done for the purpose of commercial advantage
13	or private financial gain, be fined under title 18,
14	United States Code, imprisoned not less than 2
15	years nor more than 10 years, or both;
16	"(II) in the case of a violation of subparagraph
17	(A)(ii), (iii), (iv), or (v)(II) be fined under title 18,
18	United States Code, imprisoned not less than 1 year
19	nor more than 5 years, or both;
20	"(III) in the case of a violation of subparagraph
21	(A)(i), (ii), (iii), (iv), or (v) during and in relation
22	to which the person causes serious bodily injury (as
23	defined in section 1365 of title 18, United States
24	Code) to, or places in jeopardy the life of, any per-
25	son, be fined under title 18, United States Code, im-

- 2 years, or both; and
- 3 "(IV) in the case of a violation of subparagraph
- 4 (A)(i), (ii), (iii), (iv), or (v) resulting in the death of
- 5 any person, be punished by death or imprisoned for
- 6 any term of years or for life (but not less than 20
- 7 years), fined under title 18, United States Code, or
- 8 both.
- 9 "(ii) In the case of a violation of subparagraph (A)
- 10 after 1 prior conviction for any other violation of subpara-
- 11 graph (A) has become final, the minimum term of impris-
- 12 onment shall be not less than two times the minimum term
- 13 specified in clause (i).
- 14 "(iii) In the case of a violation of subparagraph (A)
- 15 after 2 or more prior convictions for any other violations
- 16 of subparagraph (A) have become final, the minimum
- 17 term of imprisonment shall be not less than five times the
- 18 minimum term specified in clause (i).".
