A BILL

To establish the Thomas Cole National Historic Site in the State of New York, and for other purposes.

- 1 *Be it enacted by the Senate and House of Representa-*
- 2 *tives of the United States of America in Congress assembled,*
- 3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**
- 4 *(a) SHORT TITLE.—This Act may be cited as the*
- 5 *“Thomas Cole National Historic Site Act”.*

1 (b) *TABLE OF CONTENTS.*—*The table of contents of this*
 2 *Act is as follows:*

3 **SEC. 2. DEFINITIONS.**

4 *As used in this Act:*

5 (1) *The term “historic site” means the Thomas*
 6 *Cole National Historic Site established by section 4 of*
 7 *this Act.*

8 (2) *The term “Hudson River artists” means art-*
 9 *ists who were associated with the Hudson River school*
 10 *of landscape painting.*

11 (3) *The term “plan” means the general manage-*
 12 *ment plan developed pursuant to section 6(d).*

13 (4) *The term “Secretary” means the Secretary of*
 14 *the Interior.*

15 (5) *The term “Society” means the Greene County*
 16 *Historical Society of Greene County, New York, which*
 17 *owns the Thomas Cole home, studio, and other prop-*
 18 *erty comprising the historic site.*

19 **SEC. 3. FINDINGS AND PURPOSES.**

20 (a) *FINDINGS.*—*Congress finds the following:*

1 (1) *The Hudson River school of landscape paint-*
2 *ing was inspired by Thomas Cole and was character-*
3 *ized by a group of 19th century landscape artists who*
4 *recorded and celebrated the landscape and wilderness*
5 *of America, particularly in the Hudson River Valley*
6 *region in the State of New York.*

7 (2) *Thomas Cole is recognized as America's most*
8 *prominent landscape and allegorical painter of the*
9 *mid-19th century.*

10 (3) *Located in Greene County, New York, the*
11 *Thomas Cole House, also known as Thomas Cole's*
12 *Cedar Grove, is listed on the National Register of*
13 *Historic Places and has been designated as a Na-*
14 *tional Historic Landmark.*

15 (4) *Within a 15 mile radius of the Thomas Cole*
16 *House, an area that forms a key part of the rich cul-*
17 *tural and natural heritage of the Hudson River Val-*
18 *ley region, significant landscapes and scenes painted*
19 *by Thomas Cole and other Hudson River artists, such*
20 *as Frederic Church, survive intact.*

21 (5) *The State of New York has established the*
22 *Hudson River Valley Greenway to promote the preser-*
23 *vation, public use, and enjoyment of the natural and*
24 *cultural resources of the Hudson River Valley region.*

1 (6) *Establishment of the Thomas Cole National*
 2 *Historic Site will provide opportunities for the illus-*
 3 *tration and interpretation of cultural themes of the*
 4 *heritage of the United States and unique opportuni-*
 5 *ties for education, public use, and enjoyment.*

6 (b) *PURPOSES.—The purposes of this Act are—*

7 (1) *to preserve and interpret the home and stu-*
 8 *dio of Thomas Cole for the benefit, inspiration, and*
 9 *education of the people of the United States;*

10 (2) *to help maintain the integrity of the setting*
 11 *in the Hudson River Valley region that inspired ar-*
 12 *tistic expression;*

13 (3) *to coordinate the interpretive, preservation,*
 14 *and recreational efforts of Federal, State, and other*
 15 *entities in the Hudson Valley region in order to en-*
 16 *hance opportunities for education, public use, and en-*
 17 *joyment; and*

18 (4) *to broaden understanding of the Hudson*
 19 *River Valley region and its role in American history*
 20 *and culture.*

21 **SEC. 4. ESTABLISHMENT OF THOMAS COLE NATIONAL HIS-**
 22 **TORIC SITE.**

23 (a) *ESTABLISHMENT.—There is established, as an af-*
 24 *filiated area of the National Park System, the Thomas Cole*
 25 *National Historic Site in the State of New York.*

1 (b) *DESCRIPTION.*—*The historic site shall consist of the*
 2 *home and studio of Thomas Cole, comprising approxi-*
 3 *mately 3.4 acres, located at 218 Spring Street, in the village*
 4 *of Catskill, New York, as generally depicted on the boundary*
 5 *map numbered TCH/80002, and dated March 1992.*

6 **SEC. 5. RETENTION OF OWNERSHIP AND MANAGEMENT OF**
 7 **HISTORIC SITE BY GREENE COUNTY HISTORI-**
 8 **CAL SOCIETY.**

9 *The Greene County Historical Society of Greene Coun-*
 10 *ty, New York, shall continue to own, manage, and operate*
 11 *the historic site.*

12 **SEC. 6. ADMINISTRATION OF HISTORIC SITE.**

13 (a) *APPLICABILITY OF NATIONAL PARK SYSTEM*
 14 *LAWS.*—*The historic site shall be administered by the Soci-*
 15 *ety in a manner consistent with this Act and all laws gen-*
 16 *erally applicable to units of the National Park System, in-*
 17 *cluding the Act of August 25, 1916 (16 U.S.C. 1 et seq.;*
 18 *commonly known as the National Park Service Organic*
 19 *Act), and the Act of August 21, 1935 (16 U.S.C. 461 et*
 20 *seq.; commonly known as the Historic Sites, Buildings, and*
 21 *Antiquities Act).*

22 (b) *COOPERATIVE AGREEMENTS.*—

23 (1) *ASSISTANCE TO SOCIETY.*—*The Secretary*
 24 *may enter into cooperative agreements with the Soci-*
 25 *ety to preserve the Thomas Cole House and other*

1 *structures in the historic site and to assist with edu-*
2 *cation programs and research and interpretation of*
3 *the Thomas Cole House and associated landscapes.*

4 (2) *OTHER ASSISTANCE.*—*To further the pur-*
5 *poses of this Act, the Secretary may enter into cooper-*
6 *ative agreements with the State of New York, the So-*
7 *cietty, the Thomas Cole Foundation, and other public*
8 *and private entities to facilitate public understanding*
9 *and enjoyment of the lives and works of the Hudson*
10 *River artists through the provision of assistance to de-*
11 *velop, present, and fund art exhibits, resident artist*
12 *programs, and other appropriate activities related to*
13 *the preservation, interpretation, and use of the his-*
14 *toric site.*

15 (c) *ARTIFACTS AND PROPERTY.*—

16 (1) *PERSONAL PROPERTY GENERALLY.*—*The Sec-*
17 *retary may acquire personal property associated*
18 *with, and appropriate for, the interpretation of the*
19 *historic site.*

20 (2) *WORKS OF ART.*—*The Secretary may acquire*
21 *works of art associated with Thomas Cole and other*
22 *Hudson River artists for the purpose of display at the*
23 *historic site.*

24 (d) *GENERAL MANAGEMENT PLAN.*—*Within two com-*
25 *plete fiscal years after the date of the enactment of this Act,*

1 *a general management plan shall be developed for the his-*
2 *toric site by the Society, with the assistance of the Sec-*
3 *retary. Upon the completion of the plan, the Secretary shall*
4 *provide a copy of the plan to the Committee on Energy and*
5 *Natural Resources of the Senate and the Committee on Re-*
6 *sources of the House of Representatives. The plan shall in-*
7 *clude recommendations for regional wayside exhibits, to be*
8 *carried out through cooperative agreements with the State*
9 *of New York and other public and private entitles. The plan*
10 *shall be prepared in accordance with section 12(b) of Public*
11 *Law 91–383 (16 U.S.C. 1a–1 et seq.; commonly known as*
12 *the National Park System General Authorities Act).*

13 **SEC. 7. AUTHORIZATION OF APPROPRIATIONS.**

14 *There are authorized to be appropriated such sums as*
15 *are necessary to carry out this Act.*

Amend the title so as to read: “A bill to establish the Thomas Cole National Historic Site in the State of New York as an affiliated area of the National Park System.”.
