A BILL

To modify the conditions that must be met before certain alternative pay authorities may be exercised by the President with respect to Federal employees.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Federal Pay Fairness
- 5 Act of 1998".

1 SEC. 2. LIMITATION ON AUTHORITY TO PROVIDE FOR AN

- 2 ALTERNATIVE PAY PLAN.
- 3 (a) In General.—Paragraph (1) of section 5303(b)
- 4 of title 5, United States Code, is amended by striking "If,
- 5 because of national emergency or serious economic condi-
- 6 tions affecting the general welfare," and inserting "If, be-
- 7 cause of a declared state of war or severe economic condi-
- 8 tions,".
- 9 (b) Severe Economic Conditions Defined.—
- 10 Section 5303(b) of title 5, United States Code, is amended
- 11 by adding at the end the following:
- 12 "(4) For purposes of applying this subsection with
- 13 respect to any pay adjustment that is to take effect in
- 14 any calendar year, 'severe economic conditions' shall be
- 15 considered to exist if, during the 12-month period ending
- 16 2 calendar quarters before the date as of which such ad-
- 17 justment is scheduled to take effect (as determined under
- 18 subsection (a)), there occur 2 consecutive quarters of neg-
- 19 ative growth in the real Gross Domestic Product.".
- 20 (c) Conforming Amendment.—Paragraph (2) of
- 21 section 5303(b) of title 5, United States Code, is amended
- 22 by striking "an economic condition affecting the general
- 23 welfare under this subsection," and inserting "economic
- 24 conditions for purposes of this subsection,".

- 4 (a) In General.—Subsection (a) of section 5304a
- 5 of title 5, United States Code, is amended by striking "If,
- 6 because of national emergency or serious economic condi-
- 7 tions affecting the general welfare," and inserting "If, be-
- 8 cause of a declared state of war or severe economic condi-
- 9 tions,".
- 10 (b) Severe Economic Conditions Defined.—
- 11 Section 5304a of title 5, United States Code, is amended
- 12 by redesignating subsection (b) as subsection (c) and by
- 13 inserting after subsection (a) the following:
- 14 "(b) For purposes of applying this section with re-
- 15 spect to any comparability payments that are to become
- 16 payable in any calendar year, 'severe economic conditions'
- 17 shall be considered to exist if, during the 12-month period
- 18 ending 2 calendar quarters before the date as of which
- 19 such payments are scheduled to take effect (as determined
- 20 under section 5304(d)(2)), there occur 2 consecutive quar-
- 21 ters of negative growth in the real Gross Domestic Prod-
- 22 uct.".
- 23 SEC. 4. EFFECTIVE DATE.
- 24 (a) New Standards Apply Starting With any
- 25 ALTERNATIVE PAY PROPOSAL SCHEDULED TO TAKE EF-
- 26 FECT AFTER 1998.—The amendments made by this Act

- 1 shall apply with respect to any alternative pay adjust-
- 2 ments under section 5303(b) of title 5, United States
- 3 Code, and any alternative level of comparability payments
- 4 under section 5304a of such title 5, scheduled to take ef-
- 5 fect after 1998.

- 6 (b) Transition Provisions.—
- 7 (1) REVISED DEADLINE FOR ALTERNATIVE PAY
 8 PLAN REQUIRED TO BE SUBMITTED IN 1998.—For
 9 purposes of applying section 5303 of title 5, United
 10 States Code, with respect to any adjustment sched11 uled to take effect in calendar year 1999, subsection
 12 (b) of such section (as amended by section 2) shall
 13 be applied by substituting "December 1" for "Sep-

tember 1" in paragraph (1)(A) thereof.

- (2) Effect of an alternative pay proposal submitted based on earlier standards.—Any plan or report submitted under the provisions of section 5303(b) or 5304a of title 5, United States Code, as applicable, relating to any alternative pay adjustments or alternative level of comparability payments proposed to take effect after 1998, if based on the standards specified in such provisions as in effect before the date of enactment of this Act—
- 25 (A) shall not be implemented; and

1 (B) shall not preclude the submission of 2 any other plan or report under such provisions 3 as amended by this Act.
