A BILL

To amend title 49, United States Code, to require air carrier baggage liability to be not less than \$2,000 per passenger.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. MINIMUM BAGGAGE LIABILITY.
- 4 Subchapter I of chapter 417 of title 49, United States
- 5 Code, is amended by adding at the end the following:
- 6 "§ 41716. Minimum baggage liability
- 7 "(a) IN GENERAL.—The liability for provable direct
- 8 or consequential damages resulting from the disappear-
- 9 ance of, damage to, or delay in delivery of a passenger's
- 10 personal property, including baggage, that was in the cus-

- 1 tody or control of an air carrier immediately prior to such
- 2 disappearance, damage, or delay shall be not less than
- 3 \$2,000 for each passenger.
- 4 "(b) Applicability.—Subsection (a) shall apply
- 5 only to—
- 6 "(1) an air carrier that provides charter or
- 7 scheduled passenger service in interstate or overseas
- 8 air transportation; and
- 9 "(2) a flight that—
- 10 "(A) uses an aircraft designed to have a
- maximum passenger capacity of more than 60;
- 12 or
- 13 "(B) uses an aircraft that is designed to
- have a maximum passenger capacity of 60 or
- less but has on the ticket for that flight a flight
- segment that uses an aircraft designed to have
- a maximum passenger capacity of more than 60
- seats.
- 19 "(c) Notice Requirement.—An air carrier de-
- 20 scribed in subsection (b)(1) shall include on or with any
- 21 ticket for a flight described in subsection (b)(2) at least
- 22 one of the following:
- 23 "(1) Notice of any monetary limitation on its
- baggage liability to passengers.

- 1 "(2) The following notice: 'Federal law requires
- 2 any limitation on an air carriers's baggage liability
- on this flight to be at least \$2,000 per passenger.'."
- 4 SEC. 2. AMENDMENT TO TABLE OF SECTIONS.
- 5 The table of sections for subchapter I of chapter 417
- 6 of title 49, United States Code, is amended by adding at
- 7 the end the following:

"41716. Minimum baggage liability.".
