**AN ACT**

To adjust the boundaries of the Lake Chelan National Recreation Area and the adjacent Wenatchee National Forest in the State of Washington.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. BOUNDARY ADJUSTMENTS, LAKE CHELAN NA-**  
2 **TIONAL RECREATION AREA AND WENATCHEE**  
3 **NATIONAL FOREST, WASHINGTON.**

4 (a) BOUNDARY ADJUSTMENTS.—

5 (1) LAKE CHELAN NATIONAL RECREATION  
6 AREA.—The boundary of the Lake Chelan National  
7 Recreation Area, established by section 202 of Pub-  
8 lic Law 90–544 (16 U.S.C. 90a–1), is hereby ad-  
9 justed to exclude a parcel of land and waters con-  
10 sisting of approximately 88 acres, as depicted on the  
11 map entitled “Proposed Management Units, North  
12 Cascades, Washington”, numbered NP–CAS–7002A,  
13 originally dated October 1967, and revised July 13,  
14 1994.

15 (2) WENATCHEE NATIONAL FOREST.—The  
16 boundary of the Wenatchee National Forest is here-  
17 by adjusted to include the parcel of land and waters  
18 described in paragraph (1).

19 (3) AVAILABILITY OF MAP.—The map referred  
20 to in paragraph (1) shall be on file and available for  
21 public inspection in the offices of the superintendent  
22 of the Lake Chelan National Recreation Area and  
23 the Director of the National Park Service, Depart-  
24 ment of the Interior, and in the office of the Chief  
25 of the Forest Service, Department of Agriculture.

1       (b) TRANSFER OF ADMINISTRATIVE JURISDIC-  
2 TION.—Administrative jurisdiction over Federal land and  
3 waters in the parcel covered by the boundary adjustments  
4 in subsection (a) is transferred from the Secretary of the  
5 Interior to the Secretary of Agriculture, and the trans-  
6 ferred land and waters shall be managed by the Secretary  
7 of Agriculture in accordance with the laws and regulations  
8 pertaining to the National Forest System.

9       (c) LAND AND WATER CONSERVATION FUND.—For  
10 purposes of section 7 of the Land and Water Conservation  
11 Fund Act of 1965 (16 U.S.C. 460l–9), the boundaries of  
12 the Wenatchee National Forest, as adjusted by subsection  
13 (a), shall be considered to be the boundaries of the  
14 Wenatchee National Forest as of January 1, 1965.
