A BILL

To provide for the conversion of housing projects for elderly persons financed by direct loans to financing under project rental assistance contracts.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Senior Citizens" Hous-
- 5 ing Financial Restructuring Act of 1998".

1 SEC. 2. CONVERSION.

- 2 Subject to the provisions of this Act and the agree-
- 3 ment of the owner of a project assisted under section 202
- 4 of the Housing Act of 1959 (as in effect before the enact-
- 5 ment of the Cranston-Gonzalez National Affordable Hous-
- 6 ing Act) and section 8 of the United States Housing Act
- 7 of 1937, the Secretary may convert the financing of any
- 8 such housing project to financing under section 202 of the
- 9 Housing Act of 1959, as amended by section 801 of the
- 10 Cranston-Gonzalez National Affordable Housing Act (12
- 11 U.S.C. 1701q).

12 SEC. 3. DEBT FORGIVENESS.

- 13 (a) In General.—Subject to subsection (b), in con-
- 14 verting the financing of any housing project pursuant to
- 15 this Act, the Secretary may cancel any indebtedness to
- 16 the Secretary relating to any remaining principal and in-
- 17 terest under any loan for the project made under section
- 18 202 of the Housing Act of 1959 (as in effect before the
- 19 enactment of the Cranston-Gonzalez National Affordable
- 20 Housing Act).
- 21 (b) BUDGET ACT COMPLIANCE.—The authority of
- 22 the Secretary to cancel indebtedness under subsection (a)
- 23 shall be effective only to the extent or in such amounts
- 24 as are or have been provided in advance in appropriation
- 25 Acts.

1 SEC. 4. CANCELLATION OF SECTION 8 CONTRACTS AND

- 2 USE OF PROJECT FUNDS.
- 3 (a) In General.—In converting the financing of any
- 4 housing project pursuant to this Act, the Secretary may
- 5 cancel any contract for rental assistance for the project
- 6 under section 8 of the United States Housing Act of 1937.
- 7 (b) Use of Unexpended Amounts.—Amounts pre-
- 8 viously obligated for such contract that remain unex-
- 9 pended shall be used, to the extent the Secretary considers
- 10 appropriate, in accordance with subsection (d) to improve
- 11 the market viability, affordability, or service to low-income
- 12 elderly residents of the project. Any such unexpended
- 13 amounts in excess of the amount used in accordance with
- 14 subsection (d) shall be recaptured by the Secretary.
- 15 (c) Use of Project Funds.—In converting the fi-
- 16 nancing of any housing project pursuant to this Act, the
- 17 Secretary may authorize the owner of the project to use
- 18 any residual receipts held for the project that exceed \$500
- 19 per unit (or such other amount as the Secretary may pre-
- 20 scribe based on the needs of the project) in accordance
- 21 with subsection (d) to improve the market viability, afford-
- 22 ability, or service to low-income elderly residents of the
- 23 project.
- 24 (d) Eligible Activities.—Amounts are used in ac-
- 25 cordance with this subsection only if they are used—

- 1 (1) to provide rental assistance for the project, 2 under a contract for project rental assistance under 3 section 202(c)(2) of the Housing Act of 1959, which 4 has a duration that is not less than the remainder 5 of the section 8 contract canceled; or
- 6 (2) to retrofit or renovate the project or provide 7 a service coordinator for residents of the project, to 8 the same extent that such activities are authorized 9 to be provided under section 802 of the Cranston-10 Gonzalez National Affordable Housing Act to hous-11 ing assisted under such section.

12 SEC. 5. THIRD PARTY PROCESSING.

- The Secretary may enter into contracts with public or private entities as the Secretary considers appropriate to facilitate efficient processing of elderly housing project conversions under this Act.
- 17 SEC. 6. WAIVER AUTHORITY.
- The Secretary may waive the applicability of any provision of law or regulation necessary to carry out this Act.
