1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, 3 SECTION 1. PERMANENT RESIDENT STATUS FOR AUGUSTO 4 ERNESTO SEGOVIA, MARIA ISABEL SEGOVIA, 5 **EDELMIRA ISABEL** SEGOVIA, **PERLA** 6 FRANCCESCA SEGOVIA, AND AUGUSTO THOM-7 AS SEGOVIA. 8 (a) In General.—Notwithstanding subsections (a) and (b) of section 201 of the Immigration and Nationality

10 Act, Augusto Ernesto Segovia, Maria Isabel Segovia,

- 1 Edelmira Isabel Segovia, Perla Franccesca Segovia, and
- 2 Augusto Thomas Segovia shall each be eligible for
- 3 issuance of an immigrant visa or for adjustment of status
- 4 to that of an alien lawfully admitted for permanent resi-
- 5 dence upon filing an application for issuance of an immi-
- 6 grant visa under section 204 of such Act or for adjustment
- 7 of status to lawful permanent resident.
- 8 (b) Adjustment of Status.—If Augusto Ernesto
- 9 Segovia, Maria Isabel Segovia, Edelmira Isabel Segovia,
- 10 Perla Franccesca Segovia, or Augusto Thomas Segovia en-
- 11 ters the United States before the filing deadline specified
- 12 in subsection (c), he or she shall be considered to have
- 13 entered and remained lawfully and shall, if otherwise eligi-
- 14 ble, be eligible for adjustment of status under section 245
- 15 of the Immigration and Nationality Act as of the date of
- 16 the enactment of this Act.
- 17 (c) Deadline for Application and Payment of
- 18 FEES.—Subsections (a) and (b) shall apply only if the ap-
- 19 plication for issuance of an immigrant visa or the applica-
- 20 tion for adjustment of status is filed with appropriate fees
- 21 within 2 years after the date of the enactment of this Act.
- 22 (d) Reduction of Immigrant Visa Number.—
- 23 Upon the granting of an immigrant visa or permanent res-
- 24 idence to Augusto Ernesto Segovia, Maria Isabel Segovia,
- 25 Edelmira Isabel Segovia, Perla Franccesca Segovia, and

- 1 Augusto Thomas Segovia, the Secretary of State shall in-
- 2 struct the proper officer to reduce by 5, during the current
- 3 or next following fiscal year, the total number of immi-
- 4 grant visas that are made available to natives of the coun-
- 5 try of the aliens' birth under section 203(a) of the Immi-
- 6 gration and Nationality Act or, if applicable, the total
- 7 number of immigrant visas that are made available to na-
- 8 tives of the country of the aliens' birth under section
- 9 202(e) of such Act.
