### 15 **SEC. 2806. RESTORATION OF DEPARTMENT OF DEFENSE** 16 **LANDS USED BY PERMIT OR LEASE.**

17 (a) IN GENERAL.—Section 2691 of title 10, United  
 18 States Code, is amended—

19 (1) by striking from its title “from other agen-  
 20 cies”; and

21 (2) by adding at its end the following new sub-  
 22 section:

23 “(c) RESTORATION.—The Secretary of the military  
 24 department concerned may require, as part of any lease,  
 25 permit, license, or other grant of access made to any other

1 Federal agency for use of lands under the control of that  
2 military department, that such agency remove improve-  
3 ments and take any other action necessary in the judg-  
4 ment of the Secretary to restore the land used by such  
5 agency to the condition such property was in prior to its  
6 use by such agency. Any such agency shall be bound by  
7 the terms of such lease, permit, license, or other grant  
8 of access.

9           “(1) From appropriations available to such  
10 agency, such agency shall, in accordance with the  
11 terms of such lease, permit, license, or other grant  
12 of access, remove improvements and take any other  
13 action necessary in the judgment of the Secretary to  
14 restore the land used, or reimburse the military de-  
15 partment the costs of conducting the removal or res-  
16 toration itself.

17           “(2) For purposes of this section, the term  
18 “Federal agency” means any department, agency, or  
19 instrumentality of the United States.”.

20           (b) CLERICAL AMENDMENT.—The table of sections  
21 at the beginning of chapter 159 of title 10, United States  
22 Code, is amended by striking in the item relating to sec-  
23 tion 2691 “from other agencies”.
