A BILL

To provide for the sale of certain public lands in the Ivanpah Valley, Nevada, to the Clark County Department of Aviation.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as "The Ivanpah Valley Air-
- 5 port Public Lands Transfer Act".
- 6 SEC. 2. CONVEYANCE TO CLARK COUNTY DEPARTMENT OF
- 7 AVIATION.
- 8 (a) In General.—Notwithstanding the land use
- 9 planning requirements contained in sections 202 and 203
- 10 of the Federal Land Policy and Management Act of 1976

- 1 (43 U.S.C. 1711 and 1712), the Secretary of the Interior
- 2 is authorized and directed to convey, under such terms
- 3 and conditions as the Secretary deems appropriate, all
- 4 right, title, and interest of the United States in and to
- 5 the public lands identified for disposition on the map enti-
- 6 tled "Ivanpah Valley, Nevada-Airport Selections", num-
- 7 bered _____, and dated _____, to the Department of Avia-
- 8 tion of Clark County, Nevada, for the purpose of develop-
- 9 ing an airport facility and infrastructure. Such map shall
- 10 be on file and available for public inspection in the offices
- 11 of the Director and the Las Vegas District of the Bureau
- 12 of Land Management.
- 13 (b) Determination of Fair Market Value for
- 14 PHASED CONVEYANCE.—The Secretary shall convey the
- 15 lands identified in subsection (a) in smaller parcels over
- 16 a period of up to 20 years, as may be required to carry
- 17 out the phased construction and development of the air-
- 18 port facility and infrastructure. Such parcels shall be con-
- 19 veyed by the Secretary upon payment by the Department
- 20 of Aviation of Clark County, Nevada, of the fair market
- 21 value of the land, based on an appraisal of the fair market
- 22 value as of a date not later than six months after the date
- 23 of enactment of this Act.
- (c) WITHDRAWAL.—The public lands referred to in
- 25 subsection (a) are hereby withdrawn from mineral entry

- 1 under the Act of May 10, 1872 (30 U.S.C. 22 et seq.,
- 2 popularly known as the Mining Law of 1872 and the Min-

3 eral Leasing Act (30 U.S.C. 181 et seq.).
