- 3 SECTION 1. DEFINITIONS.
- 4 Section 2105(1) of the Omnibus Crime Control and
- 5 Safe Streets Act of 1968 (42 U.S.C. 3796hh-4(1)) is
- 6 amended to read as follows:
- 7 "(1) the term 'domestic violence' includes acts
- 8 or threats of violence, not including acts of self-de-

1 fense, committed by a current or former spouse of 2 the victim, by a person with whom the victim shares 3 a child in common, by a person who is cohabitating with or has cohabitated with the victim, by a person 5 who is or has been in a continuing social relationship 6 of a romantic or intimate nature with the victim, by 7 a person similarly situated to a spouse of the victim 8 under the domestic or family violence laws of the ju-9 risdiction, or by any other person against a victim 10 who is protected from that person's acts under the 11 domestic or family violence laws of the jurisdiction 12 and for other purposes.".
