Mr. Skeen introduced the following bill; which was referred to the Committee on Agriculture

A BILL

To eliminate the regional system of organizing the National Forest System and to replace the regional offices of the Forest Service with State offices.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. STATE ORGANIZATION OF NATIONAL FOREST
- 4 SYSTEM.
- 5 (a) Elimination of Regions and Regional Of-
- 6 FICES.—Beginning not later than one year after the date
- 7 of the enactment of this Act, the Secretary of Agriculture
- 8 shall no longer administer the National Forest System
- 9 using the organizational structure of Forest Service re-
- 10 gions. By the end of the one-year period beginning on the

- 1 date of the enactment of this Act, the Secretary shall
- 2 eliminate the 10 existing regional offices of the Forest
- 3 Service and replace such offices with State offices as pro-
- 4 vided in subsection (b).
- 5 (b) STATE FOREST SERVICE OFFICES.—
- 6 (1) Establishment.—Subject to paragraph
- 7 (2), the Secretary of Agriculture shall establish a
- 8 State office of the Forest Service in each State con-
- 9 taining any portion of the National Forest System.
- The Forest Service office for a State shall be re-
- sponsible for the administration of National Forest
- 12 System lands within the State.
- 13 (2) MULTI-STATE OFFICES.—The Secretary
- may establish a Forest Service office under para-
- graph (1) to serve more than one State, or consoli-
- date separate offices previously established under
- paragraph (1), if the Secretary determines that the
- total acreage of National Forest System lands in a
- 19 particular State does not justify a separate Forest
- 20 Service office for that State and the National Forest
- 21 System lands in that State can be readily managed
- through a Forest Service office in another State.
- 23 (3) Definition of State.—In this subsection,
- the term "State" includes Guam, Puerto Rico, the

- 1 Trust Territories of the Pacific Islands, and the Vir-
- 2 gin Islands.
- 3 (c) Technical Support Centers.—To facilitate
- 4 the cost-effective provision of technical support to State
- 5 Forest Service offices established under subsection (b), the
- 6 Secretary of Agriculture may establish up to six technical
- 7 support centers in the United States for the Forest Serv-
- 8 ice. The Secretary shall establish such a center at the
- 9 same location as a State office.
