## A BILL

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. PAYMENT.**

4       The Secretary of the Treasury, out of amounts not  
5       otherwise appropriated, shall pay—

1           (1) to Hilario Armijo, post office box 335,  
2       Jemez Pueblo, New Mexico, the sum of \$65,000;

3           (2) to Timothy W. Armijo, post office box 211,  
4       San Ysidro, New Mexico, the sum of \$65,000;

5           (3) to Josephine and Mike Baca (jointly), post  
6       office box 352, Jemez Pueblo, New Mexico, the sum  
7       of \$300,000;

8           (4) to Vincent Chavez, post office box 137,  
9       Jemez Pueblo, New Mexico, the sum of \$65,000;

10          (5) to David Chinana, post office box 456,  
11       Jemez Pueblo, New Mexico, the sum of \$200,000;

12          (6) to Victor Chinana, post office box 52,  
13       Jemez Pueblo, New Mexico, the sum of \$100,000;

14          (7) to Ivan T. Gachupin, post office box 196,  
15       Jemez Pueblo, New Mexico, the sum of \$90,000;

16          (8) to Michael Gachupin, post office box 143,  
17       Jemez Pueblo, New Mexico, the sum of \$100,000;

18          (9) to Frank Madalena, Jr., post office box  
19       571, Jemez Pueblo, New Mexico, the sum of  
20       \$65,000;

21          (10) to Dennis Magdalena, post office box 157,  
22       Jemez Pueblo, New Mexico, the sum of \$150,000;

23          (11) to Mary Pecos, post office box 284, Jemez  
24       Pueblo, New Mexico, the sums of—

25                (A) \$175,000; and

1 (B) \$175,000 to be held in trust for Bren-  
2 nan Toya (to be paid under circumstances that  
3 the Secretary determines will ensure the pay-  
4 ment is held safely in trust for Brennan Toya  
5 until Brennan Toya is no longer a minor);

6 (12) to Lawrence Seonia, Albuquerque Manor,  
7 post office box 7, Jemez Pueblo, New Mexico, the  
8 sum of \$125,000;

9 (13) to Roberta P. Toledo, post office box 385,  
10 Jemez Pueblo, New Mexico, the sum of \$150,000;

11 (14) to Nathaniel Tosa, post office box 241,  
12 Jemez Pueblo, New Mexico, the sum of \$65,000;

13 (15) to Allen L. Toya, Jr., post office box 142,  
14 Jemez Pueblo, New Mexico, the sum of \$65,000;

15 (16) to Ethel Waquie, post office box 393, San  
16 Fidel, New Mexico, the sums of—

17 (A) \$200,000; and

18 (B) \$200,000 to be held in trust for Vin-  
19 cent Waquie (to be paid under circumstances  
20 that the Secretary determines will ensure the  
21 payment is held safely in trust for Vincent  
22 Waquie until Vincent Waquie is no longer a  
23 minor); and

24 (17) to Veronica Waquie, post office box 53,  
25 Jemez Pueblo, New Mexico, the sum of \$300,000.

1 **SEC. 2. LIMITATION.**

2       Notwithstanding any contract, no attorney or rep-  
3 resentative may receive more than 10 percent of a pay-  
4 ment made under section 1 for services rendered in con-  
5 nection with such payment. Any person who violates this  
6 section shall be guilty of an infraction and shall be subject  
7 to a fine in the amount provided in title 18, United States  
8 Code.
