A BILL

To require that the President transmit to Congress, that the congressional Budget Committees report, and that the Congress consider a balanced budget for each fiscal year.

 - "(3) Each concurrent resolution on the budget reported by the Committee on the Budget of either House shall contain reconciliation directives described in section 310 necessary to effectuate the provisions and requirements of such resolution.".

12 TITLE III—EFFECTIVE DATE

13 SEC. 301. EFFECTIVE DATE.

This Act and the amendments made by it shall betome effective for fiscal year 1999 and shall be fully reflected in the fiscal year 1999 budget submitted by the President as required by section 1105(a) of title 31, Unitted States Code.
