- 3 (a) IN GENERAL.—The Reclamation Wastewater and
- 4 Groundwater Studies and Facilities Act (Public Law 102–
- 5 575, title XVI; 43 U.S.C. 390h et seq.) is amended—
- 6 (1) by redesignating sections 1631, 1632, and
- 7 1633 as sections 1632, 1633, and 1634, respectively;
- 8 and
- 9 (2) by inserting after section 1630 the follow-
- 10 ing:
- 11 "SEC. 1631. ALAMEDA COUNTY BRACKISH WATER DESALI-
- 12 NATION PROJECT.
- 13 "(a) AUTHORIZATION.—The Secretary, in coopera-
- 14 tion with the Alameda County Water District, California,
- 15 is authorized to participate in the design, planning, and
- 16 construction of the Alameda County Brackish Water De-
- 17 salination Project to reclaim and reuse wastewater and de-
- 18 graded groundwaters within and outside of the service
- 19 area of the Alameda County Water District in California.
- 20 "(b) Cost Share.—The Federal share of the cost
- 21 of a project described in subsection (a) shall not exceed
- 22 25 percent of the total cost.
- 23 "(c) Limitation.—The Secretary shall not provide
- 24 funds for the operation or maintenance of a project de-
- 25 scribed in subsection (a).".
