## A BILL

To amend the Social Security Act to further extend health care coverage under the Medicare program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. EXTENSION OF HEALTH CARE COVERAGE
- 4 UNDER THE MEDICARE PROGRAM.
- 5 (a) IN GENERAL.—Title II of the Social Security Act
- 6 (42 U.S.C. 301) is amended by inserting after section
- 7 226A the following new section:

| 17 | "(c) For purposes of this section, the term 'qualified        |

| 20 | sections (a) and (b), respectively, of section 107 of         |
| 21 | title 38, United States Code;                                 |
| 22 | "(2) was discharged or released from such serv-               |
| 23 | ice under conditions other than dishonorable;                 |
| 24 | "(3) has attained the age of 65; and                          |

"(4) is a citizen of the United States or an 1 2 alien lawfully admitted for permanent residence in 3 the United States.". 4 (b) Conforming Amendment.—Section 1811 of such Act (42 U.S.C. 1395c) is amended— 5 (1) by striking "and 226A" and inserting 6 ", 226A, and 226B"; 7 (2) by striking "and (3)" and inserting "(3)"; 8 9 and 10 (3) by inserting before the period the following: ", and (4) certain individuals who do not meet the 11 12 conditions specified in clause (1), (2), or (3) but who 13 are qualified World War II Filipino veterans". (c) Effective Date.—The amendments made by 14 15 this section shall apply to benefits for months beginning after September 1998.
