## A BILL

To amend title 38, United States Code, to repeal the recently enacted provisions of law that limit the authority of the Department of Veterans Affairs to provide compensation and treatment for smoking-related illnesses suffered by veterans of the Armed Forces.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Benefits Res-
- 5 toration Act of 1998".

#### 1 SEC. 2. FINDINGS.

- 2 Congress makes the following findings:
- 3 (1) The Department of Defense contributed to
- 4 the smoking habits of military personnel. For exam-
- 5 ple, cigarettes were included in standard food and
- 6 hygiene kits during World War II and the Korean
- 7 Conflict. In many cases, the United States provided
- 8 a soldier's first eigarette.
- 9 (2) Cigarettes were distributed to troops during
- the Vietnam War.
- 11 (3) The United States, through the Department
- of Veterans Affairs, should provide compensation
- and health care to veterans for service-connected
- smoking-related illnesses.
- 15 SEC. 3. REPEAL OF LAW LIMITING ESTABLISHMENT OF
- 16 SERVICE-CONNECTION FOR DISABILITIES RE-
- 17 LATING TO THE USE OF TOBACCO PROD-
- 18 UCTS.
- 19 (a) Repeal.—Section 1103 of title 38, United States
- 20 Code, is repealed.
- 21 (b) CLERICAL AMENDMENT.—The table of sections
- 22 at the beginning of chapter 11 of such title is amended
- 23 by striking out the item relating to section 1103.
- (c) Effective Date.—The amendments made by
- 25 this section shall apply to any claim for compensation re-

- 1 ceived by the Secretary of Veterans Affairs before, on, or
- 2 after the date of the enactment of this Act.
- 3 SEC. 4. FUNDS NOT REQUIRED TO BE OFFSET FROM OTHER
- 4 PROGRAMS.
- 5 The Director of the Office of Management and Budg-
- 6 et may not make any estimate of changes in direct spend-
- 7 ing outlays under section 252(d) of the Balanced Budget
- 8 and Emergency Deficit Control Act of 1985 (2 U.S.C.
- 9 902(d)) for any fiscal year resulting from the enactment
- 10 of this Act.
