A BILL

- To amend the Elementary and Secondary Education Act of 1965 and the Head Start Act to promote high-quality family literacy programs and train parents effectively to teach their children, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Family Literacy Im-
 - 5 provement Act of 1998".
 - 6 SEC. 2. FINDINGS.
 - 7 The Congress finds as follows:

1	(1) Family literacy programs provide important
2	literacy assistance to families.
3	(2) Family literacy programs assist parents in
4	improving their literacy skills, attaining self-suffi-
5	ciency, and helping their children succeed in school
6	(3) Family literacy programs empower parents
7	by providing them with the skills to interact posi-
8	tively with their children, with respect to their chil-
9	dren's education.
10	(4) Family literacy programs encourage parents
11	to read to their children, which is a key component
12	of children's academic success.
13	(5) Existing family literacy programs should be
14	strengthened in order to ensure that they are as ef-
15	fective as possible in serving the literacy needs of at-
16	risk families in the United States.
17	TITLE I—AMENDMENTS TO EVEN
18	START FAMILY LITERACY
19	PROGRAMS
20	SEC. 101. RESERVATION FOR GRANTS.
21	Section 1202(c) of the Elementary and Secondary
22	Education Act of 1965 (20 U.S.C. 6362(c)) is amended
23	to read as follows:
24	"(c) Reservation for Grants.—

1 "(1) Grants authorized.—In any fiscal year 2 in which the amount appropriated to carry out this 3 part exceeds the amount appropriated to carry out this part for the preceding fiscal year, the Secretary 5 shall reserve such funds in excess of the amount ap-6 propriated for such preceding fiscal years as do not 7 exceed \$1,000,000 to award grants, on a competitive 8 basis, to States to enable such States to plan and 9 implement, statewide family literacy initiatives to co-10 ordinate and integrate existing Federal, State, and 11 local literacy resources consistent with the purposes 12 of this part. Such coordination and integration shall 13 include funds available under the Adult Education 14 Act, Head Start, this part, part A of this title, and 15 part A of title IV of the Social Security Act. "(2) Consortia.— 16 17 "(A) ESTABLISHMENT.—To receive 18 grant under this subsection, a State shall estab-19 lish a consortium of the following State-level 20 programs: 21 "(i) Programs under this title. 22 "(ii) Programs under the Head Start 23 Act. 24 "(iii) Programs under the Adult Edu-

cation Act.

1	"(iv) All other State-funded preschool
2	programs and programs providing literacy
3	services to adults.

- "(B) PLAN.—To receive a grant under this subsection, the consortium established by a State shall create a plan to use a portion of the State's resources, derived from the programs referred to in subparagraph (A), to strengthen and expand family literacy services in such State.
- "(3) Reading instruction.—Statewide family literacy initiatives implemented under this subsection shall base reading instruction on reliable, replicable research on reading.
- "(4) Technical assistance.—The Secretary shall provide, directly or through a grant or contract with an organization with experience in the development and operation of successful family literacy services, technical assistance to States receiving a grant under this subsection.
- "(5) MATCHING REQUIREMENT.—The Secretary shall not make a grant to a State under this subsection unless the State agrees that, with respect to the costs to be incurred by the eligible consortium in carrying out the activities for which the grant was

1	awarded, the State will make available non-Federal
2	contributions in an amount equal to not less than
3	the Federal funds provided under the grant.".
4	SEC. 102. DEFINITIONS.
5	Section 1202(e) of the Elementary and Secondary
6	Education Act of 1965 (20 U.S.C. 6362(e)) is amended—
7	(1) in paragraph (3), by striking "and" at the
8	end;
9	(2) by redesignating paragraphs (3) and (4) as
10	paragraphs (4) and (7), respectively;
11	(3) by inserting after paragraph (2) the follow-
12	ing:
13	"(3) the term 'family literacy services' means
14	services provided to participants on a voluntary basis
15	that are of sufficient intensity in terms of hours,
16	and of sufficient duration, to make sustainable
17	changes in a family (such as eliminating or reducing
18	welfare dependency) and that integrate—
19	"(A) interactive literacy activities between
20	parents and their children;
21	"(B) activities equipping parents to moti-
22	vate, teach, and otherwise partner with their
23	children in learning;

1	"(C) parent literacy training, including
2	training that contributes to economic self-suffi-
3	ciency; and
4	"(D) appropriate instruction for children
5	of parents receiving parent literacy services;";
6	and
7	(4) by inserting after paragraph (4) the follow-
8	ing:
9	"(5) the term 'reading' means the process of
10	comprehending the meaning of written text by de-
11	pending on—
12	"(A) the ability to use phonics skills, that
13	is, knowledge of letters and sounds, to decode
14	printed words quickly and effortlessly, both si-
15	lently and aloud;
16	"(B) the ability to use previously learned
17	strategies for reading comprehension; and
18	"(C) the ability to think critically about
19	the meaning, message, and aesthetic value of
20	the text;
21	"(6) the term 'reliable, replicable research'
22	means objective, valid, scientific studies that—
23	"(A) include rigorously defined samples of
24	subjects that are sufficiently large and rep-

1	resentative to support the general conclusions
2	drawn;
3	"(B) rely on measurements that meet es-
4	tablished standards of reliability and validity;
5	"(C) test competing theories, where mul-
6	tiple theories exist;
7	"(D) are subjected to peer review before
8	their results are published; and
9	"(E) discover effective strategies for im-
10	proving reading skills; and".
11	SEC. 103. PROGRAM ELEMENTS.
12	Section 1205 of the Elementary and Secondary Edu-
13	cation Act of 1965 (20 U.S.C. 6365) is amended—
14	(1) in paragraph (9), by striking "and" at the
15	end;
16	(2) in paragraph (10), by striking the period at
17	the end and inserting "; and; and
18	(3) by adding at the end the following:
19	"(11) include a dedicated period of time for
20	parents and their children to interact for the specific
21	purposes of enhancing the childrens' learning and
22	developing a relationship of reciprocal learning and
23	teaching.".

- 23 (a) In General.—The Elementary and Secondary
- 24 Education Act of 1965 is amended—
- 25 (1) by redesignating section 1210 as section

1	(2) by inserting after section 1209 the follow-
2	ing:
3	"SEC. 1210. INDICATORS OF PROGRAM QUALITY.
4	"Each State receiving funds under this part shall de-
5	velop, based on the best available research and evaluation
6	data, indicators of program quality for programs assisted
7	under this part. Such indicators shall be used to monitor,
8	evaluate, and improve such programs within the State.
9	Such indicators shall include the following:
10	"(1) With respect to eligible participants in a
11	program who are adults—
12	"(A) achievement in the areas of reading,
13	writing, English language acquisition, problem
14	solving, and numeracy;
15	"(B) receipt of a high school diploma or a
16	general equivalency diploma;
17	"(C) entry into a postsecondary school, job
18	retraining program, or employment or career
19	advancement, including the military; and
20	"(D) such other indicators as the State
21	may develop.
22	"(2) With respect to eligible participants in a
23	program who are children—
24	"(A) improvement in ability to read on
25	grade level or reading readiness:

1	"(B) school attendance;
2	"(C) grade retention and promotion; and
3	"(D) such other indicators as the State
4	may develop.".
5	(b) State Level Activities.—Section 1203(a) of
6	the Elementary and Secondary Education Act of 1965 (20
7	U.S.C. 6363(a)) is amended—
8	(1) in paragraph (1), by striking "and" at the
9	end;
10	(2) in paragraph (2), by striking the period at
11	the end and inserting "; and"; and
12	(3) by adding at the end the following:
13	"(3) carrying out section 1210.".
14	(c) AWARD OF SUBGRANTS.—Paragraphs (3) and (4)
15	of section 1208(b) of the Elementary and Secondary Edu-
16	cation Act of 1965 (20 U.S.C. 6368) are amended to read
17	as follows:
18	"(3) Continuing eligibility.—In awarding
19	subgrant funds to continue a program under this
20	part for the second, third, or fourth year, the State
21	educational agency shall evaluate the program based
22	on the indicators of program quality developed by
23	the State under section 1210. Such evaluation shall
24	take place after the conclusion of the startup period,
25	if any.

1	"(4) Insufficient progress.—The State
2	educational agency may refuse to award subgrant
3	funds if such agency finds that the eligible entity
4	has not sufficiently improved the performance of the
5	program, as evaluated based on the indicators of
6	program quality developed by the State under sec-
7	tion 1210, after—
8	"(A) providing technical assistance to the
9	eligible entity; and
10	"(B) affording the eligible entity notice
11	and an opportunity for a hearing.".
12	SEC. 107. RESEARCH.
13	The Elementary and Secondary Education Act of
14	1965, as amended by section 106 of this Act, is further
15	amended by inserting after section 1210 the following:
16	"SEC. 1211. RESEARCH.
17	"(a) In General.—The Secretary shall carry out,
18	through grant or contract, research into the components
19	of successful family literacy services, to be used—
20	"(1) to improve the quality of existing pro-
21	grams assisted under this part or other family lit-
22	eracy programs carried out under this Act or the
23	Adult Education Act; and

1	"(2) to develop models for new programs to be
2	carried out under this Act or the Adult Education
3	Act.
4	"(b) Dissemination.—The National Institute for
5	Literacy shall disseminate the results of the research de-
6	scribed in subsection (a) to States and recipients of sub-
7	grants under this part.".

10	SEC. 201. AMENDMENTS RELATING TO FAMILY LITERACY.
11	The Head Start Act (42 U.S.C. 9831–9852) is
12	amended—
13	(1) in section 637(4) is amended to read as fol-
14	lows:
15	"(4) The term 'family literacy services' means
16	services that—
17	"(A) are provided to participants who re-
18	ceive the services on a voluntary basis;
19	"(B) are of sufficient intensity, and of suf-
20	ficient duration, to make sustainable changes in
21	a family (such as eliminating or reducing de-
22	pendence on income-based public assistance);
23	and
24	"(C) integrate each of—

1	"(i) interactive literacy activities be-
2	tween parents and their children;
3	"(ii) training for parents on being
4	partners with their children in learning;
5	"(iii) parent literacy training, includ-
6	ing training that contributes to economic
7	self-sufficiency; and
8	"(iv) appropriate instruction for chil-
9	dren of parents receiving the parent lit-
10	eracy training.",
11	(2) in section 639—
12	(A) in subsection (a) by striking "1998"
13	and inserting "2003",
14	(B) in subsection (b)—
15	(i) in paragraph (1)—
16	(I) by striking "1998" and in-
17	serting "2003", and
18	(II) by striking "and" at the end,
19	(ii) in paragraph (2)—
20	(I) by striking "1998" and in-
21	serting "2003", and
22	(II) by striking the period at the
23	end and inserting "; and", and
24	(C) by adding at the end the following:

1 "(3) not less than \$5,000,000 for fiscal year 2 1999, and such sums as may be necessary for fiscal 3 years 2000 through 2003, to carry out section 648B.", and 4 5 (3) by inserting after section 648A the follow-6 ing: 7 "SEC. 648B. FAMILY LITERACY SERVICES. "From funds reserved under section 639(b)(3), the 8 9 Secretary— "(1) shall provide grants through a competitive 10 11 process, based upon the quality of the family literacy 12 service proposal and taking into consideration geo-13 graphic and urban/rural representation, for not more 14 than 100 Head Start agencies to initiate provision 15 of family literacy services through collaborative part-16 nerships with entities that provide adult education 17 services, entities carrying out Even Start programs 18 under part B of chapter 1 of title 1 of the Elemen-19 tary and Secondary Education Act of 1965 (20 20 U.S.C. 274 et seq.), or entities that provide other 21 services deemed necessary for the provision of family 22 literacy services; and

"(2) may—

23

1	"(A) provide training and technical assist-
2	ance to Head Start agencies that already pro-
3	vide family literacy services;
4	"(B) designate as mentor programs, and
5	provide financial assistance to, Head Start
6	agencies that demonstrate effective implementa-
7	tion of family literacy services, based on im-
8	proved outcomes of children and their parents,
9	to enable such agencies to provide training and
10	technical assistance to other agencies that seek
11	to implement, or improve implementation of,
12	family literacy services; and
13	"(C) award grants or make other assist-
14	ance available to facilitate training and tech-
15	nical assistance to programs for development of
16	collaboration agreements with other service pro-
17	viders.
18	In awarding such grants or assistance, the Secretary shall
19	give special consideration to an organization that has ex-
20	perience in the development and operation of successful
21	family literacy services.".
