# A BILL

To prohibit acquisitions of land or waters for the National Wildlife Refuge System if wildlife refuge revenue sharing payments have not been made for the preceding fiscal year.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. LIMITATION ON ACQUISITIONS FOR NATIONAL
- 4 WILDLIFE REFUGE SYSTEM.
- 5 (a) Limitation.—No amounts may be expended by
- 6 the United States in a fiscal year for acquisition of land
- 7 or waters (or interests therein) for the National Wildlife
- 8 Refuge System if the Secretary of the Interior has not

- 1 made all payments required for the preceding fiscal year
- 2 by section 401(c)(1) of the Act of June 15, 1935 (16)
- 3 U.S.C. 715s(c)(1)).
- 4 (b) Rule of Construction.—A provision of law
- 5 enacted after the date of the enactment of this Act shall
- 6 not be considered to amend, repeal, or otherwise modify
- 7 or supersede subsection (a) unless the provision expressly
- 8 refers to subsection (a).
- 9 (c) Conforming Amendment to Land and Water
- 10 Conservation Fund Act of 1965.—Subsection (b) of
- 11 section 7 of the Land and Water Conservation Fund Act
- 12 of 1965 (16 U.S.C. 460l–9(b)) is amended to read as
- 13 follows:
- 14 "(b) Acquisition Restrictions.—
- 15 "(1) Use for authorized acquisitions.—
- Appropriations from the fund pursuant to this sec-
- tion shall not be used for acquisition unless such ac-
- quisition is otherwise authorized by law: *Provided*,
- 19 however, That appropriations from the fund may be
- used for preacquisition work in instances where au-
- 21 thorization is imminent and where substantial mone-
- tary savings could be realized.
- "(2) Use for wildlife refuge acquisi-
- 24 TIONS.—Appropriations from the fund pursuant to

- 1 this Act shall not be used in a fiscal year for acquisi-
- 2 tion of land or waters (or interests therein) for the
- 3 National Wildlife Refuge System if the Secretary
- 4 has not made all payments required for the preced-
- 5 ing fiscal year by section 401(c)(1) of the Act of
- 6 June 15, 1935 (16 U.S.C. 715s(c)(1)).".

### 7 SEC. 2. APPLICATION.

- 8 Section 1 shall not apply to any acquisition the Sec-
- 9 retary of the Interior is obligated to carry out under a
- 10 contract entered into by the Secretary of the Interior on
- 11 or before the date of the enactment of this Act.
