A BILL

To require Executive agencies to identify which of its regulations impose requirements which conflict with the requirements of other Executive agencies, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Regulatory Harmoni-
- 5 zation Act".
- 6 SEC. 2. CONFLICT LIST.
- 7 (a) GENERAL RULE.—Within 180 days of the date
- 8 of the enactment of this Act and annually thereafter, each

- 1 Executive agency shall publish a proposed list of which
- 2 of its regulations impose requirements which are poten-
- 3 tially in conflict with the requirements of the regulations
- 4 of another Executive agency or with the requirements of
- 5 legislation.
- 6 (b) Publication and Comment.—When an Execu-
- 7 tive agency publishes its proposed list under subsection
- 8 (a), such agency shall in such publication provide oppor-
- 9 tunity for public comment on its list. The agency shall pro-
- 10 vide at least 150 days for such comment.
- 11 (c) Publication of Final List.—Based on the
- 12 comments received under subsection (b), an Executive
- 13 agency shall revise its proposed list and publish a final
- 14 list not later than 180 days after the publication of the
- 15 proposed list under subsection (a).
- 16 (d) Proposed Changes and Recommenda-
- 17 TIONS.—Within 180 days of the date of the publication
- 18 of a final list under subsection (c), each Executive agency
- 19 shall—
- 20 (1) publish proposed changes in its regulations
- 21 to resolve the conflict identified by the agency in the
- list published under subsection (c); and
- 23 (2) submit to Congress recommendations for
- changes in legislation to resolve the conflict identi-
- 25 fied under subsection (c).

- 1 Within 360 days of the date of the publication of proposed
- 2 changes under paragraph (1), such proposed changes shall
- 3 be issued as final changes.
- 4 (d) Enforcement.—Upon the expiration of 36
- 5 months after the date of the enactment of this Act, it shall
- 6 be an affirmative defense to a civil action brought against
- 7 a person to enforce a Federal regulatory requirement that
- 8 such requirement is potentially in conflict with another
- 9 regulatory requirement with which such person is in com-
- 10 pliance.

11 SEC. 3. DEFINITIONS.

- For purposes of this Act—
- 13 (1) the term "Executive agency" has the mean-
- ing prescribed for such term by section 105 of title
- 5, United States Code;
- 16 (2) the term "potentially in conflict" means
- that a requirement of a Federal regulation overlaps
- with, is inconsistent with, or conflicts with another
- requirement of a Federal regulation or Federal stat-
- 20 ute and includes establishing labeling requirements
- 21 that are not identical for the same product, estab-
- lishing packaging requirements for the same product
- 23 that are not identical, establishing training require-
- 24 ments that are not identical on the same subject
- 25 matter, or establishing third party notification or

- warning requirements that are not identical for
 goods or services;
- 3 (3) the term "resolve the conflict" to amend a 4 regulation or a law so that a regulation is no longer 5 potentially in conflict; and
- 6 (4) the term "regulation" means any Federal 7 regulation or any other administrative agency action 8 that has the force of law.
