A BILL

To codify without substantive change laws related to Patriotic and National Observances, Ceremonies, and Organizations and to improve the United States Code.

- 1 Be it enacted by the Senate and House of Representatives of the United 2 States of America in Congress assembled,
- 3 SECTION 1. TITLE 36, UNITED STATES CODE.
- 4 Title 36, United States Code, is amended as follows:
- 5 (1) In section 902, strike subsections (b) and (c) and substitute the following:
- 7 "(b) REQUIRED DISPLAY.—The POW/MIA flag shall be displayed at the
- 8 locations specified in subsection (d) of this section on POW/MIA flag dis-
- 9 play days. The display serves—

1 "(1) as the symbol of the Nation's concern and commitment to 2 achieving the fullest possible accounting of Americans who, having been 3 prisoners of war or missing in action, still remain unaccounted for; and 4 "(2) as the symbol of the Nation's commitment to achieving the full-5 est possible accounting for Americans who in the future may become prisoners of war, missing in action, or otherwise unaccounted for as a 6 7 result of hostile action. 8 "(c) Days for Flag Display.—(1) For purposes of this section, POW/ 9 MIA flag display days are the following: 10 "(A) Armed Forces Day, the third Saturday in May. "(B) Memorial Day, the last Monday in May. 11 12 "(C) Flag Day, June 14. 13 "(D) Independence Day, July 4. 14 "(E) National POW/MIA Recognition Day. 15 "(F) Veterans Day, November 11. 16 "(2) In addition to the days specified in paragraph (1) of this subsection, 17 POW/MIA flag display days include— 18 "(A) in the case of display at medical centers of the Department of 19 Veterans Affairs (required by subsection (d)(7) of this section), any 20 day on which the flag of the United States is displayed; and 21 "(B) in the case of display at United States Postal Service post of-22 fices (required by subsection (d)(8) of this section), the last business 23 day before a day specified in paragraph (1) that in any year is not 24 itself a business day. 25 "(d) Locations for Flag Display.—The locations for the display of the POW/MIA flag under subsection (b) of this section are the following: 26 27 "(1) The Capitol. 28 "(2) The White House. 29 "(3) The Korean War Veterans Memorial and the Vietnam Veterans 30 Memorial. 31 "(4) Each national cemetery. 32 "(5) The buildings containing the official office of— 33 "(A) the Secretary of State; 34 "(B) the Secretary of Defense; 35 "(C) the Secretary of Veterans Affairs; and 36 "(D) the Director of the Selective Service System. 37 "(6) Each major military installation, as designated by the Secretary 38 of Defense. 39 "(7) Each medical center of the Department of Veterans Affairs. 40 "(8) Each United States Postal Service post office.

- 1 "(e) COORDINATION WITH OTHER DISPLAY REQUIREMENT.—Display of 2 the POW/MIA flag at the Capitol pursuant to subsection (d)(1) of this sec-
- 3 tion is in addition to the display of that flag in the Rotunda of the Capitol
- 4 pursuant to Senate Concurrent Resolution 5 of the 101st Congress, agreed
- 5 to on February 22, 1989 (103 Stat. 2533).
- 6 "(f) DISPLAY TO BE IN A MANNER VISIBLE TO THE PUBLIC.—Display
- 7 of the POW/MIA flag pursuant to this section shall be in a manner de-
- 8 signed to ensure visibility to the public.
- 9 "(g) Limitation.—This section may not be construed or applied so as
- 10 to require any employee to report to work solely for the purpose of providing
- 11 for the display of the POW/MIA flag.".
- 12 (2) In section 2102(b), strike "designated personnel" and substitute
- "personnel made available to the Commission".
- 14 (3) In section 2501(2), insert "solicit," before "accept,".
- 15 (4)(A) Insert after chapter 201 the following:

 - "(3) actively publicizing the roles of enlisted personnel in the United States Air Force;
 - "(4) participating in civil and military activities, youth programs, and fundraising campaigns that benefit the United States Air Force;
 - "(5) providing for the mutual welfare of members of the corporation and their families;
 - "(6) assisting in recruiting for the United States Air Force;
 - "(7) assembling together for social activities;
 - "(8) maintaining an adequate Air Force for our beloved country;
 - "(9) fostering among the members of the corporation a devotion to fellow airmen; and
 - "(10) serving the United States and the United States Air Force loyally, and doing all else necessary to uphold and defend the Constitution of the United States.
- "(b) Corporate Function.—The corporation shall function as an educational, patriotic, civic, historical, and research organization under the laws of the District of Columbia.

"§ 20204. Membership

- "(a) ELIGIBILITY.—Except as provided in this chapter, eligibility for membership in the corporation and the rights and privileges of members are as provided in the bylaws and articles of incorporation.
- "(b) Nondiscrimination.—The terms of membership may not discriminate on the basis of race, color, religion, sex, disability, age, or national origin.

"§ 20205. Governing body

SECTION 2. TECHNICAL AMENDMENTS TO OTHER LAWS

The amendment made by section 1(8) of this Act shall take effect as if included in the provisions of Public Law 105–225, as of the date of enactment of Public Law 105-225.

31 SECTION 4. LEGISLATIVE PURPOSE AND CONSTRUCTION.

- 32 (a) No Substantive Change.—(1) Section 1 of this Act restates, with-33 out substantive change, laws enacted before September 5, 1998, that were 34 replaced by section 1. Section 1 may not be construed as making a sub-35 stantive change in the laws replaced.
- (2) Laws enacted after September 4, 1998, that are inconsistent with this
 Act supersede this Act to the extent of the inconsistency.
- 38 (b) References.—A reference to a law replaced by this Act, including 39 a reference in a regulation, order, or other law, is deemed to refer to the 40 corresponding provision enacted by this Act.

- (c) Continuing Effect.—An order, rule, or regulation in effect under a law replaced by this Act continues in effect under the corresponding provision enacted by this Act until repealed, amended, or superseded.
- (d) ACTIONS AND OFFENSES UNDER PRIOR LAW.—An action taken or an offense committed under a law replaced by this Act is deemed to have been taken or committed under the corresponding provision enacted by this Act.
- (e) INFERENCES.—An inference of a legislative construction is not to be drawn by reason of the location in the United States Code of a provision enacted by this Act or by reason of a heading of the provision.
- (f) Severability.—If a provision enacted by this Act is held invalid, all valid provisions that are severable from the invalid provision remain in effect. If a provision enacted by this Act is held invalid in any of its applications, the provision remains valid for all valid applications that are severable from any of the invalid applications.

- (a) INFERENCES OF REPEAL.—The repeal of a law by this Act may not be construed as a legislative inference that the provision was or was not in effect before its repeal.
