A BILL

To amend the Controlled Substances Act to provide penalties for open air drug markets, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Open Air Drug Market
- 5 Penalty Act of 1998".
- 6 SEC. 2. PENALTIES FOR OPEN AIR DRUG MARKETS.
- 7 (a) In General.—Part D of the Controlled Sub-
- 8 stances Act (21 U.S.C. 841 et seq.) is amended by adding
- 9 at the end the following:

| 17 | "(c) As used in this section, the term 'specified Fed- |

| 22 | ment that may be imposed equals or exceeds 5 |
