A BILL

To provide a location in Arlington, Virginia, for construction of a memorial to honor the men and women who have served in the United States Air Force.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. LOCATION OF UNITED STATES AIR FORCE ME-
- 4 MORIAL.
- 5 (a) IN GENERAL.—The Air Force Memorial Founda-
- 6 tion (referred to in this section as the "Foundation") may
- 7 construct a memorial to honor the men and women who

1	have served in the United States Air Force and the prede-
2	cessors of the United States Air Force.
3	(b) GENERAL LOCATION.—The Secretary of Defense
4	in coordination with the Foundation, shall provide a site
5	for the memorial described in subsection (a) (referred to
6	in this section as the "memorial") on a portion of the par-
7	cel of Federal land located in Arlington County, Virginia
8	and known as the "Arlington Naval Annex", which is
9	bounded generally by—
10	(1) Southgate Road to the north;
11	(2) Columbia Pike, to the intersection of
12	Southgate Road, to the east;
13	(3) Shirley Memorial Highway (Interstate
14	Route 395) to the south; and
15	(4) Oak Street to the west.
16	(c) Selection of Specific Site.—
17	(1) In general.—The Foundation may—
18	(A) in consultation with the Secretary of
19	Defense, select the site of the memorial within
20	the parcel described in subsection (b); and
21	(B) provide notification of the selection
22	and a description of the boundaries of the site
23	selected, to the Secretary of Defense.
24	(2) LOCATION.—Upon receipt of the notifica-
25	tion described in paragraph (1)(B), the Secretary of

- 1 Defense shall permit the use of the site selected by
- 2 the Foundation under paragraph (1), including land
- 3 under Wing 8 of Federal Office Building #2, for
- 4 construction of the memorial and associated facili-
- 5 ties.
- 6 (3) Preparation for construction.—Not
- 7 later than 2 years after the date of enactment of
- 8 this Act, the Secretary of Defense, in coordination
- 9 with the Foundation, shall remove all structures and
- make necessary improvements to the site selected
- 11 under paragraph (1) in preparation for construction
- of the memorial.
- 13 (d) Reimbursement of Site-Specific Ex-
- 14 Penses.—On receipt from the Foundation of documenta-
- 15 tion of site-specific expenses associated with the proposal
- 16 to locate the memorial on the parcel described in section
- 17 2(a), the Secretary of Defense shall reimburse the Foun-
- 18 dation for all such expenses incurred by the Foundation.
- 19 SEC. 2. PRESERVATION OF IWO JIMA WAR MEMORIAL.
- 20 (a) IN GENERAL.—Effective beginning on the date
- 21 of commencement of construction at the site selected
- 22 under section 1(c), no person (including any governmental
- 23 entity) may construct any monument, memorial, or other
- 24 structure on the parcel of Federal land in Arlington Coun-
- 25 ty, Virginia, that is bounded generally by—

1	(1) Arlington Boulevard (United States Route
2	50) to the north;
3	(2) Jefferson Davis Highway (Virginia Route
4	110) to the east;
5	(3) Marshall Drive to the south; and
6	(4) Meade Street to the west.
7	(b) Existing Memorials and Structures.—
8	Nothing in subsection (a) applies to the United States Ma-
9	rine Corps Memorial (commonly known as the "Iwo Jima
10	Memorial") or to the Netherlands Carillon.
11	(c) Utilities.—Nothing in subsection (a) affects the
12	construction, reconstruction, repair, or relocation of any
13	utility facility, including any sewer, electrical, water sup-
14	ply, or communication facility.
15	(d) Relation to Arlington National Ceme-
16	TERY.—Nothing in this section affects any use of land de-
17	scribed in subsection (a) by the Secretary of the Army for
18	incorporation into Arlington National Cemetery.
