Mr. Waxman introduced the following bill; which was referred to the Committee on Commerce

## A BILL

To amend the Public Health Service Act to establish an Office of Autoimmune Diseases at the National Institutes of Health, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "NIH Office of Auto-
- 5 immune Diseases Act of 1998".
- 6 SEC. 2. ESTABLISHMENT OF OFFICE OF AUTOIMMUNE DIS-
- 7 EASES AT NATIONAL INSTITUTES OF HEALTH.
- 8 Title IV of the Public Health Service Act (42 U.S.C.
- 9 281 et seq.) is amended by inserting after section 404E
- 10 the following section:

| 8  | "(1) In general.—The Director of the Office               |
| 9  | shall carry out the following:                            |
| 10 | "(A) The Director shall recommend an                      |
| 11 | agenda for conducting and supporting research             |
| 12 | on autoimmune diseases through the national               |
| 13 | research institutes. The agenda shall provide             |
| 14 | for a broad range of research relating to bio-            |
| 15 | medical, psychosocial, and rehabilitative issues          |
| 16 | including studies of the disproportionate impact          |
| 17 | of such diseases on women.                                |
| 18 | "(B) The Director shall with respect to                   |
| 19 | autoimmune diseases promote coordination and              |
| 20 | cooperation among the national research insti-            |
| 21 | tutes and entities whose research is supported            |
| 22 | by such institutes.                                       |
| 23 | "(C) The Director shall promote the suffi-                |
| 24 | cient allocation of the resources of the National         |

1 Institutes of Health for conducting and sup-2 porting research on autoimmune diseases.

"(D) The Director shall biennially prepare a report that describes the projects of research on autoimmune diseases being conducted or supported through the national research institutes, and that identifies particular projects or types of projects that should in the future be conducted or supported by the national research institutes or other entities in the field of research on autoimmune diseases.

"(2) Principal advisor regarding autoimmune diseases.—With respect to autoimmune diseases, the Director of the Office shall serve as the principal advisor to the Secretary, the Assistant Secretary for Health, and the Director of NIH, and shall provide advice to the Director of the Centers for Disease Control and Prevention and the Commissioner of Food and Drugs.

"(c) Coordinating Committee.—The Director of NIH shall ensure that there is in operation a committee to coordinate the activities of the National Institutes of Health with respect to autoimmune diseases, that the committee is designated as the Autoimmune Diseases Coordi-

nating Committee, and that, to the extent possible, such

- 1 Coordinating Committee includes liaison members from
- 2 other Federal health agencies, including the Centers for
- 3 Disease Control and Prevention and the Food and Drug
- 4 Administration.
- 5 "(d) Definition.—For purposes of this section, the
- 6 term 'autoimmune diseases' includes rheumatoid arthritis,
- 7 systemic lupus erthematosus, multiple sclerosis, juvenile-
- 8 onset diabetes, Sjögren's syndrome, scleroderma, and
- 9 other diseases or disorders as determined by the Sec-
- 10 retary.
- 11 "(e) AUTHORIZATION OF APPROPRIATIONS.—For the
- 12 purpose of carrying out this section, there are authorized
- 13 to be appropriated \$750,000 for fiscal year 1999, and
- 14 such sums as may be necessary for each subsequent fiscal
- 15 year.".
