A BILL

To amend the Marine Protection, Research, and Sanctuaries Act of 1972 relating to the dumping of dredged material in Long Island Sound, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Long Island Sound
- 5 Preservation and Protection Act".

SEC. 2. DUMPING OF DREDGED MATERIALS IN LONG

- 2 ISLAND SOUND.
- 3 Section 106(f) of the Marine Protection, Research,
- 4 and Sanctuaries Act of 1972 (33 U.S.C. 1416(f)) is
- 5 amended to read as follows:
- 6 "(f) Dumping of Dredged Material in Long Is-
- 7 LAND SOUND.—
- 8 "(1) In general.—No dredged material from
- 9 any Federal project, or from any non-Federal
- project, that contains any of the constituents prohib-
- ited as other than trace contaminants (as defined by
- the Federal ocean dumping criteria set forth in sec-
- tion 227.6 of title 40 of the Code of Federal Regula-
- tions) may be dumped in Long Island Sound or
- 15 Block Island Sound, except in cases in which it is
- demonstrated to the Administrator, and the Admin-
- istrator certifies by publication in the Federal Reg-
- ister, that the dumping of the dredged material con-
- taining such constituents will not cause significant
- 20 undesirable effects, including the threat associated
- 21 with bioaccumulation of such constituents in marine
- organisms.
- 23 "(2) Federal projects exceeding 25,000
- YARDS.—In addition to other provisions of law and
- 25 notwithstanding the specific exclusion relating to
- dredged material in the first sentence in section

102(a), any dumping of dredged material in Long 1 2 Island Sound from a Federal project (or pursuant to 3 Federal authorization) by a non-Federal applicant 4 exceeding 25,000 cubic yards shall comply with the 5 criteria established pursuant to the second sentence 6 of section 102(a) relating to the effects of dumping. "(3) RELATION TO OTHER LAW.—Subsection 7 (d) shall not apply to this subsection.". 8
