2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION.**

2 The Federal building located at 100 Alabama Street
3 NW., in Atlanta, Georgia, shall be known and designated
4 as the “Sam Nunn Federal Center”.

5 **SEC. 2. REFERENCES.**

6 Any reference in a law, map, regulation, document,
7 paper, or other record of the United States to the Federal
8 building referred to in section 1 shall be deemed to be
9 a reference to the “Sam Nunn Federal Center”.

10 **SECTION 1. DESIGNATION.**

11 *The Federal building located at 61 Forsyth Street SW.,*
12 *in Atlanta, Georgia, shall be known and designated as the*
13 *“Sam Nunn Atlanta Federal Center”.*

14 **SEC. 2. REFERENCES.**

15 *Any reference in a law, map, regulation, document,*
16 *paper, or other record of the United States to the Federal*
17 *building referred to in section 1 shall be deemed to be a*
18 *reference to the “Sam Nunn Atlanta Federal Center”.*

Amend the title so as to read: “A bill to designate the Federal building located at 61 Forsyth Street SW., in Atlanta, Georgia, as the ‘Sam Nunn Atlanta Federal Center’.”.
