A BILL

To reduce the number of executive branch political appointees.

1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, 3 SECTION 1. REDUCTION IN NUMBER OF POLITICAL AP-4 POINTEES. 5 (a) DEFINITION.—For purposes of this section, the term "political appointee" means any individual who— 7 (1) is employed in a position listed in sections 8 5312 through 5316 of title 5, United States Code 9 (relating to the Executive Schedule);

1	(2) is a limited term appointee, limited emer-
2	gency appointee, or noncareer appointee in the Sen-
3	ior Executive Service, as defined under section
4	3132(a) (5), (6), and (7) of title 5, United States
5	Code, respectively; or

- 6 (3) is employed in a position in the executive 7 branch of the Government under schedule C of sub-8 part C of part 213 of title 5 of the Code of Federal 9 Regulations.
- 10 (b) LIMITATION.—The President, acting through the 11 Office of Management and Budget and the Office of Per12 sonnel Management, shall take such actions as necessary (including reduction-in-force actions under applicable pro14 cedures) to ensure that the number of political appointees 15 shall not, during any fiscal year beginning after September 16 30, 1997, exceed a total of 2,300 (determined on a full17 time equivalent basis).
