A BILL

To amend title XVIII of the Social Security Act to continue full-time-equivalent resident reimbursement for an additional one year under Medicare for direct graduate medical education for residents enrolled in combined approved primary care medical residency training programs.

- 4 This Act may be cited as the "Primary Care Pro-

1	SEC. 2. MEDICARE SPECIAL REIMBURSEMENT RULE FOR
2	PRIMARY CARE COMBINED RESIDENCY PRO-
3	GRAMS.
4	(a) In General.—Section 1886(h)(5)(G) of the So-
5	cial Security Act (42 U.S.C. 1395ww(h)(5)(G)) is amend-
6	ed—
7	(1) in clause (i), by striking "and (iii)" and in-
8	serting ", (iii), and (iv)"; and
9	(2) by adding at the end the following:
10	"(iv) Special rule for primary
11	CARE COMBINED RESIDENCY PROGRAMS.—
12	(I) In the case of a resident enrolled in a
13	combined medical residency training pro-
14	gram in which all of the individual pro-
15	grams (that are combined) are for training
16	a primary care resident (as defined in sub-
17	paragraph (H)), the period of board eligi-
18	bility shall be the minimum number of
19	years of formal training required to satisfy
20	the requirements for initial board eligibility
21	in the longest of the individual programs
22	plus one additional year.
23	"(II) A resident enrolled in a com-
24	bined medical residency training program
25	that includes an obstetrics and gynecology
26	program qualifies for the period of board

1	eligibility under subclause (I) if the other
2	programs such resident combines with such
3	obstetrics and gynecology program are for
4	training a primary care resident.".
5	(b) Effective Date.—The amendments made by
6	subsection (a) apply to combined medical residency pro-
7	grams in effect on or after July 1, 1996.
