1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Prohibition on Finan-					
3	cial Transactions With Countries Supporting Terrorism					
4	Act of 1997".					
5	SEC. 2. FINANCIAL TRANSACTIONS WITH TERRORISTS.					
6	Section 2332d of title 18, United States Code, (relat-					
7	ing to financial transactions) is amended—					
8	(1) in subsection (a)—					
9	(A) by striking "Except as provided in reg-					
10	ulations issued by the Secretary of the Treas-					
11	ury, in consultation with the Secretary of State,					
12	whoever" and inserting "Whoever"; and					
13	(B) by inserting "of 1979" after "Export					
14	Administration Act"; and					
15	(2) in subsection $(b)(1)$, by inserting after					
16	"1956(c)(4)" the following: ", except that such term					
17	does not include any transaction ordinarily incident					
18	to—					
19	"(A) routine diplomatic relations among					
20	countries;					
21	"(B) an official act by a representative of,					
22	or an act which is authorized by and conducted					
23	on behalf of, the United States Government;					
24	"(C) the broadcasting or reporting of news					
25	by organizations regularly engaged in such ac-					
26	tivity; or					

1	"(D) the provision or purchase of assist-			
2	ance intended to relieve human suffering, in-			
3	cluding medical services, supplies, and equip-			
4	ment;			
5	"(E) the receipt of emergency medical			
6	services;			
7	"(F) any postal, telegraphic, or other per-			
8	sonal communication which does not involve a			
9	transfer of anything of value;			
10	"(G) the protection of intellectual property			
11	rights of any United States person;			
12	"(H) the performance of any contract or			
13	agreement that was entered into before June			
14	12, 1997, but not those renewed after such			
15	date;			
16	"(I) the provision of hospitality or trans-			
17	portation services; or			
18	"(J) the payment of a claim to any United			
19	States person".			
20	SEC. 3. REPORT ON EFFECTS OF ENACTMENT.			
21	Beginning not later than one year after the date of			
22	enactment of this Act, the Secretary of the Treasury, in			
23	consultation with the Secretary of State, shall issue an an-			
24	nual report to Congress on—			

1	(1) the impact of this prob	nibition on	United
2	States businesses; and		
3	(2) any means by which a	a negative	impact
