A BILL

To develop the economy of Samoa.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "American Samoa De-
- 5 velopment Act of 1997".

1 SEC. 2. ESTABLISHMENT AND MEMBERSHIP.

- 2 (a) Establishment.—There is hereby established a
- 3 Commission on the Economic Future of American Samoa
- 4 (hereafter in this Act referred to as the "Commission").
- 5 The Commission shall consist of six members appointed
- 6 by the President, three of whom shall be selected from
- 7 nominations made by the Governor of American Samoa,
- 8 and the Secretary of Interior, ex officio. The President
- 9 shall designate one of the appointed members of the Com-
- 10 mission to be Chairman. Members of the Commission shall
- 11 be appointed for the life of the Commission.
- 12 (b) QUALIFICATIONS.—Members of the Commission
- 13 appointed by the President shall be persons who, by virtue
- 14 of their background and experience, are particularly suited
- 15 to contribute to the achievement of the purposes of the
- 16 Commission.
- 17 (c) Expenses.—Members of the Commission shall
- 18 serve without compensation, but shall may be reimbursed
- 19 for travel, subsistence and other necessary expenses in-
- 20 curred by them in the performance of their duties in ac-
- 21 cordance with sections 5702 and 5703 of title 5, United
- 22 States Code.
- 23 (d) Vacancy.—Any vacancy in the Commission shall
- 24 be filled in the same manner as the original appointment
- 25 was made.

1 SEC. 3. PURPOSE AND REPORT.

2	(a) In General.—The purpose of the Commission
3	is to make recommendations to the President and Con-
4	gress on the policies and actions necessary to provide for
5	a secure and self-sustaining future for the local economy
6	of American Samoa through 2020 and on the role of the
7	Federal Government related thereto. In developing rec-
8	ommendations, the Commission shall—
9	(1) solicit and analyze information on projected
10	private sector development, including, but not lim-
11	ited to, tourism, manufacturing and industry, agri-
12	culture and transportation and shifting trends based
13	on alternative forecasts of economic, political and so-
14	cial conditions in the Pacific;
15	(2) analyze capital infrastructure, education, so-
16	cial, health and environmental needs in light of these
17	alternative forecasts;
18	(3) assemble relevant demographic, economic
19	and revenue and expenditure data from over the
20	past twenty-five years;
21	(4) review the application of Federal laws and
22	programs and the effects of such laws and programs
23	on the local economy and make such recommenda-
24	tions for changes in the application as the Commis-
25	sion deems advisable; and

- 1 (5) consider the impact of Federal trade and
- 2 other international agreements, including, but not
- 3 limited to those related to marine resources, on
- 4 American Samoa and make such recommendations
- 5 as may be necessary to minimize or eliminate any
- 6 adverse effects on the local economy.
- 7 (b) Report.—The recommendations of the Commis-
- 8 sion shall be transmitted in a report to the President, the
- 9 Committee on Energy and Natural Resources of the Unit-
- 10 ed States Senate and the Committee on Resources of the
- 11 United States House of Representatives no later than
- 12 June 30, 1999. The report shall set forth the basis for
- 13 the recommendations and shall include an analysis of the
- 14 capability of American Samoa to meet projected needs
- 15 based on reasonable alternative economic, political and so-
- 16 cial conditions in the Pacific Basin. The report shall also
- 17 include projections of the need for direct or indirect Fed-
- 18 eral assistance for operations and infrastructure over the
- 19 next decade and what additional assistance will be nec-
- 20 essary to develop the local economy to a level sufficient
- 21 to minimize or eliminate the need for direct Federal oper-
- 22 ational assistance.
- 23 (c) Inclusion of Historical Overview.—As part
- 24 of its report, the Commission shall also include an over-
- 25 view of the history of American Samoa and its relationship

- 1 to the United States from 1872, with emphasis on those
- 2 events or actions that affect future economic development
- 3 and shall include, as an appendix to its report, copies of
- 4 the relevant documents, including, but not limited to, the
- 5 Tripartite Agreement signed on December 2, 1899, in
- 6 Washington, District of Columbia and the documents of
- 7 Cessions of 1900 and 1904.
- 8 SEC. 4. POWERS AND DUTIES.
- 9 (a) IN GENERAL.—(1) The Commission may—
- 10 (A) hold such hearings, sit and act at such
- 11 times and places, take such testimony and receive
- such evidence as it may deem advisable;
- (B) use the United States mail in the same
- manner and upon the same conditions as depart-
- ments and agencies of the United States; and
- 16 (C) within available funds, incur such expenses
- and enter into contracts or agreements for studies
- and surveys with public and private organizations
- and transfer funds to Federal agencies to carry out
- the Commission's functions.
- 21 (2) In carrying out paragraph (1)(A), the Commis-
- 22 sion shall conduct public meetings in Tutuila, Ofu,
- 23 Olosega and Ta'u.
- 24 (b) Office Space and Staff.—Within funds avail-
- 25 able for the Commission, the Secretary of the Interior

- 1 shall provide such office space, furnishings, equipment,
- 2 staff and fiscal and administrative services as the Commis-
- 3 sion may require.
- 4 (c) Other Federal Assistance.—The President,
- 5 upon request of the Commission, may direct the head of
- 6 any Federal agency or department to assist the Commis-
- 7 sion and if so directed such head shall—
- 8 (1) furnish the Commission to the extent per-
- 9 mitted by law and within available appropriations
- such information as may be necessary for carrying
- out the functions of the Commission and as may be
- available to or procurable by such department or
- agency; and
- 14 (2) detail to temporary duty with the Commis-
- sion on a reimbursable basis such personnel within
- 16 his administrative jurisdiction as the Commission
- may need or believe to be useful for carrying out its
- functions, each such detail to be without loss of se-
- 19 niority, pay or other employee status.

20 SEC. 5. CHAIRMAN.

- 21 Subject to general policies that the Commission may
- 22 adopt, the Chairman of the Commission shall be the chief
- 23 executive officer of the Commission and shall exercise its
- 24 executive and administrative powers. The Chairman may
- 25 make such provisions as he may deem appropriate author-

- 1 izing the performance of his executive and administrative
- 2 functions by the staff of the Commission.
- 3 SEC. 6. FUNDING.
- 4 The Department of the Interior is authorized to pro-
- 5 vide up to \$300,000 each in fiscal years 1997 and 1998
- 6 in technical assistance funding for the work of the Com-
- 7 mission.
- 8 SEC. 7. TERMINATION.
- 9 The Commission shall terminate three months after
- 10 the transmission of the report and recommendations under
- 11 section 3(b).
