A BILL

To authorize the establishment of the National African-American Museum within the Smithsonian Institution.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National African
5 American Museum Act”.

6 **SEC. 2. FINDINGS.**

7 (a) FINDINGS.—The Congress finds that—

8 (1) the presentation and preservation of African
9 American life, art, history, and culture within the
10 National Park System and other Federal entities is
11 inadequate;

12 (2) the inadequate presentation and preserva-
13 tion of African American life, art, history, and cul-
14 ture seriously restricts the ability of the people of
15 the United States, particularly African Americans,
16 to understand themselves and their past;

17 (3) African American life, art, history, and cul-
18 ture includes the varied experiences of Africans in
19 slavery and freedom and the continued struggles for
20 full recognition of citizenship and treatment with
21 human dignity;

22 (4) in enacting Public Law 99–511, the Con-
23 gress encouraged support for the establishment of a
24 commemorative structure within the National Park
25 System, or on other Federal lands, dedicated to the

1 promotion of understanding, knowledge, opportunity,
2 and equality for all people;

3 (5) the establishment of a national museum and
4 the conducting of interpretive and educational pro-
5 grams, dedicated to the heritage and culture of Afri-
6 can Americans, will help to inspire and educate the
7 people of the United States regarding the cultural
8 legacy of African Americans and the contributions
9 made by African Americans to the society of the
10 United States; and

11 (6) the Smithsonian Institution operates 15
12 museums and galleries, a zoological park, and 5
13 major research facilities, none of which is a national
14 institution devoted solely to African American life,
15 art, history, or culture.

16 **SEC. 3. ESTABLISHMENT OF THE NATIONAL AFRICAN**
17 **AMERICAN MUSEUM.**

18 (a) ESTABLISHMENT.—There is established within
19 the Smithsonian Institution a Museum, which shall be
20 known as the “National African American Museum”.

21 (b) PURPOSE.—The purpose of the Museum is to pro-
22 vide—

23 (1) a center for scholarship relating to African
24 American life, art, history, and culture;

1 (2) a location for permanent and temporary ex-
2 hibits documenting African American life, art, his-
3 tory, and culture;

4 (3) a location for the collection and study of ar-
5 tifacts and documents relating to African American
6 life, art, history, and culture;

7 (4) a location for public education programs re-
8 lating to African American life, art, history, and cul-
9 ture; and

10 (5) a location for training of museum profes-
11 sionals and others in the arts, humanities, and
12 sciences regarding museum practices related to Afri-
13 can American life, art, history, and culture.

14 **SEC. 4. LOCATION AND CONSTRUCTION OF THE NATIONAL**
15 **AFRICAN AMERICAN MUSEUM.**

16 The Board of Regents is authorized to plan, design,
17 reconstruct, and renovate the Arts and Industries Build-
18 ing of the Smithsonian Institution to house the Museum.

19 **SEC. 5. BOARD OF TRUSTEES OF MUSEUM.**

20 (a) ESTABLISHMENT.—There is established in the
21 Smithsonian Institution the Board of Trustees of the Na-
22 tional African American Museum.

23 (b) COMPOSITION AND APPOINTMENT.—The Board
24 of Trustees shall be composed of 23 members as follows:

1 (1) The Secretary of the Smithsonian Institu-
2 tion.

3 (2) An Assistant Secretary of the Smithsonian
4 Institution, designated by the Board of Regents.

5 (3) Twenty-one individuals of diverse disciplines
6 and geographical residence who are committed to the
7 advancement of knowledge of African American art,
8 history, and culture appointed by the Board of Re-
9 gents, of which 9 members shall be from among in-
10 dividuals nominated by African American museums,
11 historically black colleges and universities, and cul-
12 tural or other organizations.

13 (c) TERMS.—

14 (1) IN GENERAL.—Except as provided in para-
15 graph (2), members of the Board of Trustees shall
16 be appointed for terms of 3 years. Members of the
17 Board of Trustees may be reappointed.

18 (2) STAGGERED TERMS.—As designated by the
19 Board of Regents at the time of initial appointments
20 under paragraph (3) of subsection (a), the terms of
21 7 members shall expire at the end of 1 year, the
22 terms of 7 members shall expire at the end of 2
23 years, and the terms of 7 members shall expire at
24 the end of 3 years.

1 (d) VACANCIES.—A vacancy on the Board of Trust-
2 ees shall not affect its powers and shall be filled in the
3 manner in which the original appointment was made. Any
4 member appointed to fill a vacancy occurring before the
5 expiration of the term for which the predecessor of the
6 member was appointed shall be appointed for the remain-
7 der of the term.

8 (e) NONCOMPENSATION.—Except as provided in sub-
9 section (f), members of the Board of Trustees shall serve
10 without pay.

11 (f) EXPENSES.—Members of the Board of Trustees
12 shall receive per diem, travel, and transportation expenses
13 for each day, including traveltime, during which they are
14 engaged in the performance of the duties of the Board
15 of Trustees in accordance with section 5703 of title 5,
16 United States Code, with respect to employees serving
17 intermittently in the Government service.

18 (g) CHAIRPERSON.—The Board of Trustees shall
19 elect a chairperson by a majority vote of the members of
20 the Board of Trustees.

21 (h) MEETINGS.—The Board of Trustees shall meet
22 at the call of the chairperson or upon the written request
23 of a majority of its members, but shall meet not less than
24 2 times each year.

1 (i) QUORUM.—A majority of the Board of Trustees
 2 shall constitute a quorum for purposes of conducting busi-
 3 ness, but a lesser number may receive information on be-
 4 half of the Board of Trustees.

5 (j) VOLUNTARY SERVICES.—Notwithstanding section
 6 1342 of title 31, United States Code, the chairperson of
 7 the Board of Trustees may accept for the Board of Trust-
 8 ees voluntary services provided by a member of the Board
 9 of Trustees.

10 **SEC. 6. DUTIES OF THE BOARD OF TRUSTEES OF THE MU-**
 11 **SEUM.**

12 (a) IN GENERAL.—The Board of Trustees shall—

13 (1) recommend annual budgets for the Mu-
 14 seum;

15 (2) consistent with the general policy estab-
 16 lished by the Board of Regents, have the sole au-
 17 thority to—

18 (A) loan, exchange, sell, or otherwise dis-
 19 pose of any part of the collections of the Mu-
 20 seum, but only if the funds generated by such
 21 disposition are used for additions to the collec-
 22 tions of the Museum or for additions to the en-
 23 dowment of the Museum;

1 (B) subject to the availability of funds and
2 the provisions of annual budgets of the Mu-
3 seum, purchase, accept, borrow, or otherwise
4 acquire artifacts and other property for addi-
5 tion to the collections of the Museum;

6 (C) establish policy with respect to the uti-
7 lization of the collections of the Museum; and

8 (D) establish policy regarding program-
9 ming, education, exhibitions, and research, with
10 respect to the life and culture of African Ameri-
11 cans, the role of African Americans in the his-
12 tory of the United States, and the contributions
13 of African Americans to society;

14 (3) consistent with the general policy estab-
15 lished by the Board of Regents, have authority to—

16 (A) provide for restoration, preservation,
17 and maintenance of the collections of the Mu-
18 seum;

19 (B) solicit funds for the Museum and de-
20 termine the purposes to which those funds shall
21 be used;

22 (C) approve expenditures from the endow-
23 ment of the Museum, or of income generated
24 from the endowment, for any purpose of the
25 Museum; and

1 (D) consult with, advise, and support the
2 Director in the operation of the Museum;

3 (4) establish programs in cooperation with
4 other African American museums, historically black
5 colleges and universities, historical societies, edu-
6 cational institutions, cultural and other organiza-
7 tions for the education and promotion of under-
8 standing regarding African American life, art, his-
9 tory, and culture;

10 (5) support the efforts of other African Amer-
11 ican museums, historically black colleges and univer-
12 sities, and cultural and other organizations to edu-
13 cate and promote understanding regarding African
14 American life, art, history, and culture, including—

15 (A) development of cooperative programs
16 and exhibitions;

17 (B) identification, management, and care
18 of collections;

19 (C) participation in the training of mu-
20 seum professionals; and

21 (D) creating opportunities for—

22 (i) research fellowships; and

23 (ii) professional and student intern-
24 ships;

1 (6) adopt bylaws to carry out the functions of
2 the Board of Trustees; and

3 (7) report annually to the Board of Regents on
4 the acquisition, disposition, and display of African
5 American objects and artifacts and on other appro-
6 priate matters.

7 **SEC. 7. DIRECTOR AND STAFF.**

8 (a) IN GENERAL.—The Secretary of the Smithsonian
9 Institution, in consultation with the Board of Trustees,
10 shall appoint a Director who shall manage the Museum.

11 (b) APPLICABILITY OF CERTAIN CIVIL SERVICE
12 LAWS.—The Secretary of the Smithsonian Institution
13 may—

14 (1) appoint the Director and 5 employees under
15 subsection (a), without regard to the provisions of
16 title 5, United States Code, governing appointments
17 in the competitive service; and

18 (2) fix the pay of the Director and such 5 em-
19 ployees, without regard to the provisions of chapter
20 51 and subchapter III of chapter 53 of such title,
21 relating to classification and General Schedule pay
22 rates.

23 **SEC. 8. DEFINITIONS.**

24 For purposes of this Act:

1 (1) The term “Board of Regents” means the
2 Board of Regents of the Smithsonian Institution.

3 (2) The term “Board of Trustees” means the
4 Board of Trustees of the National African American
5 Museum established in section 5(a).

6 (3) The term “Museum” means the National
7 African American Museum established under section
8 3(a).

9 (4) The term “Arts and Industries Building”
10 means the building located on the Mall at 900 Jef-
11 ferson Drive, S.W. in Washington, the District of
12 Columbia.

13 **SEC. 9. AUTHORIZATION OF APPROPRIATIONS.**

14 There are authorized to be appropriated such sums
15 as may be necessary only for costs directly relating to the
16 operation and maintenance of the Museum.
