A BILL

To provide for the conversion of existing temporary United States district judgeships to permanent status, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ADDITIONAL JUDGESHIP FOR NORTHERN DIS-
- 4 TRICT OF ALABAMA.
- 5 The President shall appoint, by and with the advice
- 6 and consent of the Senate, one additional district judge
- 7 for the Northern District of Alabama.

1 SEC. 2. CONVERSION OF TEMPORARY JUDGESHIPS TO PER-

- 2 MANENT JUDGESHIPS.
- 3 The existing district judgeships for the eastern dis-
- 4 trict of California, the southern district of Illinois, the
- 5 northern district of New York, and the eastern district of
- 6 Virginia authorized by section 203(c) of the Judicial Im-
- 7 provements Act of 1990 (Public Law 101–650, 28 U.S.C.
- 8 133 note) shall, as of the date of the enactment of this
- 9 Act, be authorized under section 133 of title 28, United
- 10 States Code, and the incumbents in those offices shall hold
- 11 the office under section 133 of title 28, United States
- 12 Code, as amended by this Act.
- 13 SEC. 3. COMMENCEMENT DATE OF TEMPORARY JUDGE-
- 14 SHIPS.
- 15 Section 203(c) of the Judicial Improvements Act of
- 16 1990 (Public Law 101–650, 28 U.S.C. 133 note) is
- 17 amended by striking the last three sentences and inserting
- 18 the following: "In the western district of Michigan, the
- 19 first vacancy in the office of district judge occurring after
- 20 December 1, 1995, shall not be filled. In the eastern dis-
- 21 trict of Pennsylvania, the first vacancy in the office of dis-
- 22 trict judge occurring five years or more after the confirma-
- 23 tion date of the judge named to fill the temporary judge-
- 24 ship created by this subsection shall not be filled. In the

- 1 district of Hawaii, the central district of Illinois, the dis-
- 2 trict of Kansas, the eastern district of Missouri, the north-
- 3 ern district of Ohio, and the district of Nebraska, the first
- 4 vacancy in the office of district judge occurring 10 years
- 5 or more after the confirmation date of a judge named to
- 6 fill a temporary judgeship created by this subsection shall
- 7 not be filled. For districts named in this subsection for
- 8 which multiple judgeships are created by this Act, the last
- 9 of those judgeships filled shall be the judgeship created
- 10 under this subsection.".
